Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB26-1063 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Strike the Health & Human Services Committee Report, dated February
2 24, 2026, and substitute:

3 "Amend printed bill, strike everything below the enacting clause and
4 substitute:

5 "SECTION 1. In Colorado Revised Statutes, **add 25.5-5-428** as
6 follows:

7 **25.5-5-428. Secure transportation providers - accessible list.**

8 THE STATE DEPARTMENT SHALL PUBLISH ON THE STATE
9 DEPARTMENT'S WEBSITE AN EASILY ACCESSIBLE LIST OF SECURE
10 TRANSPORTATION PROVIDERS, AS DEFINED IN SECTION 27-65-102, THAT
11 HAVE CONTRACTS WITH MANAGED CARE ENTITIES. THE LIST MUST
12 INCLUDE THE CONTACT INFORMATION FOR THE SECURE TRANSPORTATION
13 PROVIDER, INCLUDING AN ACTIVE PHONE NUMBER OR WEBSITE.

14 **SECTION 2.** In Colorado Revised Statutes, 27-50-404, **add**
15 (1)(d) as follows:

16 **27-50-404. Care coordination - responsibilities of behavioral**
17 **health administrative services organizations - coordination with**
18 **managed care entities.**

19 (1) (d) THE BHA SHALL PUBLISH ON THE BHA'S WEBSITE AN
20 EASILY ACCESSIBLE LIST OF SECURE TRANSPORTATION PROVIDERS, AS
21 DEFINED IN SECTION 27-65-102, THAT HAVE CONTRACTS WITH
22 BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATIONS. THE
23 LIST MUST INCLUDE THE CONTACT INFORMATION FOR THE SECURE
24 TRANSPORTATION PROVIDER, INCLUDING AN ACTIVE PHONE NUMBER OR
25 WEBSITE.

26 **SECTION 3. Act subject to petition - effective date.** This act

1 takes effect at 12:01 a.m. on the day following the expiration of the
2 ninety-day period after final adjournment of the general assembly (August
3 12, 2026, if adjournment sine die is on May 13, 2026); except that, if a
4 referendum petition is filed pursuant to section 1 (3) of article V of the
5 state constitution against this act or an item, section, or part of this act
6 within such period, then the act, item, section, or part will not take effect
7 unless approved by the people at the general election to be held in
8 November 2026 and, in such case, will take effect on the date of the
9 official declaration of the vote thereon by the governor."

10 Page 1, strike lines 101 through 106 and substitute "**CONCERNING**
11 **PUBLISHING AN EASILY ACCESSIBLE LIST OF SECURE TRANSPORTATION**
12 **PROVIDERS ON CERTAIN DEPARTMENTS' WEBSITES.**".
