After consideration on the merits, the Committee recommends the following:

HB25-1041 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, line 3, after "(2)(c.5)" insert "and (7)".
- 2 Page 2, line 6, after "**contracts -**" insert "**report -**".
- 3 Page 2, strike lines 11 and 12 and substitute "AN INDIVIDUAL WHO
4 ENGAGES IN OR IS ELIGIBLE TO ENGAGE IN AN INTERCOLLEGIATE SPORT
5 FOR AN INSTITUTION. "STUDENT ATHLETE" DOES NOT MEAN AN
6 INDIVIDUAL WHO ENGAGES IN A HIGH SCHOOL SPORT."
- 7 Page 3, line 10, after "OR" insert "A COLLEGIATE".
- 8 Page 3, line 14, after "ATTORNEY." add "AN INDIVIDUAL WHO IS UNDER
9 EIGHTEEN YEARS OF AGE MUST BE REPRESENTED IN ANY NEGOTIATION BY
10 A PARENT OR GUARDIAN. THE INDIVIDUAL AND THEIR PARENT OR
11 GUARDIAN MAY ALSO BE REPRESENTED BY AN ATTORNEY OR OTHER
12 COMPETENT REPRESENTATIVE."
- 13 Page 3, line 15, after "OR" insert "A COLLEGIATE".
- 14 Page 4, after line 9 insert:

15 "(7) (a) ON OR BEFORE JANUARY 15, 2026, AND ON OR BEFORE
16 EACH JANUARY 15 THEREAFTER, EACH INSTITUTION SHALL SUBMIT TO THE
17 DEPARTMENT OF HIGHER EDUCATION A COPY OF THE ANNUAL REPORT
18 THAT EACH INSTITUTION IS REQUIRED TO ANNUALLY SUBMIT TO THE
19 ORGANIZATION WITH AUTHORITY OVER INTERCOLLEGIATE ATHLETICS,
20 CONSISTENT WITH THE REPORTING REQUIREMENTS ADOPTED BY THE
21 ORGANIZATION WITH AUTHORITY OVER INTERCOLLEGIATE ATHLETICS. THE

1 DATA IN THE REPORT INCLUDES GENDER- AND SPORT-BASED SPENDING IN
2 AREAS INCLUDING BUDGETS, SALARIES, PARTICIPATION, FINANCIAL AID,
3 AND, IF OR WHEN REQUIRED, REVENUE SHARING PAYMENTS.

4 (b) THE DEPARTMENT OF HIGHER EDUCATION SHALL PUBLISH AND
5 MAINTAIN THE REPORTS THAT IT RECEIVES PURSUANT TO THIS SUBSECTION
6 (7) ON ITS PUBLIC WEBSITE."

7 Page 4, strike lines 19 through 23 and substitute:

8 "(XXIV) (A) PERSONALLY IDENTIFIABLE INFORMATION THAT IS
9 CONTAINED WITHIN AN AGREEMENT OR A CONTRACT CONCERNING A
10 STUDENT ATHLETE'S OR A PROSPECTIVE STUDENT ATHLETE'S NAME, IMAGE,
11 OR LIKENESS, OR ANY COMMUNICATION OR MATERIAL RELATED TO AN
12 AGREEMENT OR A CONTRACT CONCERNING A STUDENT ATHLETE'S OR A
13 PROSPECTIVE STUDENT ATHLETE'S NAME, IMAGE, OR LIKENESS."

14 Page 4, before line 24 insert:

15 "(B) AS USED IN THIS SUBSECTION (3)(a)(XXIV), "PERSONALLY
16 IDENTIFIABLE INFORMATION" MEANS INFORMATION THAT COULD
17 REASONABLY BE USED TO IDENTIFY AN INDIVIDUAL, INCLUDING FIRST AND
18 LAST NAME; RESIDENCE OR OTHER PHYSICAL ADDRESS; EMAIL ADDRESS;
19 TELEPHONE NUMBER; BIRTH DATE; LICENSE FEE PAID TO THE STUDENT
20 ATHLETE OR PROSPECTIVE STUDENT ATHLETE FOR THE USE OF THEIR
21 NAME, IMAGE, OR LIKENESS; CREDIT CARD INFORMATION; OR SOCIAL
22 SECURITY NUMBER."

23 Page 4, line 24, strike "(B)" and substitute "(C)".
