Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB21-1233 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Finance Committee Report, dated April 22, 2021, page 2, line
- 2 29, after "RETAINED." insert "IN NO EVENT SHALL A TRANSFEREE BE
- 3 ALLOWED TO CLAIM AN AMOUNT GREATER THAN THE AMOUNT SPECIFIED
- 4 IN THE CERTIFICATE ISSUED TO THE TRANSFEREE."

- 5 Page 2 of the report, line 32, after "CERTIFICATION" insert "ISSUED FOR
- 6 USE ON OR AFTER JANUARY 1, 2021,".

- 7 Page 3 of the report, line 1, afer "CREDITS" insert "CERTIFIED BY THE
- 8 DIVISION".

- 9 Page 5 of the report, after line 6 insert:

- 10 "Page 10 of the printed bill, line 1, strike "2014," and substitute "2021,".

- 11 Page 10 of the bill, line 14, strike "2014," and substitute "2021,".

- 12 Page 5 of the report, after line 29 insert:

- 13 "Page 11 of the bill, strike lines 13 through 21 and substitute:

- 14 **"SECTION 5. Appropriation.** (1) For the 2021-22 state fiscal
- 15 year, \$254,372 is appropriated to the department of regulatory agencies.
- 16 This appropriation is from the conservation cash fund created in section

1 12-15-107, C.R.S. To implement this act, the department may use this
2 appropriation as follows:

3 (a) \$158,666 for use by the division of conservation for
4 conservation easement program costs, which amount is based on an
5 assumption that the division will require an additional 2.0 FTE; and

6 (b) \$95,706 for the purchase of legal services.

7 (2) For the 2021-22 state fiscal year, \$206,998 is appropriated to
8 the department of revenue. This appropriation is from the general fund.
9 To implement this act, the department may use this appropriation as
10 follows:

11 (a) \$159,145 for tax administration IT system (GenTax) support;
12 and

13 (b) \$47,853 for the purchase of legal services.

14 (3) For the 2021-22 state fiscal year, \$143,559 is appropriated to
15 the department of law. This appropriation is from reappropriated funds
16 received from the department of regulatory agencies under subsection
17 (1)(b) and the department of revenue under subsection (2)(b) of this
18 section and is based on an assumption that the department of law will
19 require an additional 0.9 FTE. To implement this act, the department of
20 law may use this appropriation to provide legal services for the
21 department of regulatory agencies and the department of revenue.

22 **SECTION 6. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, or safety."

25 Page 1 of the bill, line 103, strike "EASEMENT." and substitute
26 "EASEMENT, AND, IN CONNECTION THEREWITH, MAKING AN
27 APPROPRIATION."."
