

Proposed Draft LLS 18-0067 - Chart of Sections Affecting each Principal Department

To aid the reader, the bill is organized in the following order:

3 sections in the Administrative Organization Act that apply to all principal departments:

Section 1 - Legislative declaration, §24-1-101

Section 2 - Definitions, §24-1-105;

Section 3 - Conforming repeal of §24-1-129, some of which is incorporated into §24-1-105.

Sections that are grouped together for each principal department:

The statutory section in the Administrative Organization Act that sets forth the structure of each principal department of state government in the order in which the departments appear in the Administrative Organization Act, followed by the conforming amendments in organic sections for that principal department.

This chart shows the sections that affect each principal department in the order in which that department is addressed in the bill.
