In accordance with the statutory reporting requirements cited below, the Division of Motor Vehicles of the Colorado Department of Revenue (Department) is providing this report for your consideration.

Section 42-3-203(3)(d)(II)(B), C.R.S. Temporary Registration Permits

The Department shall notify the legislative council staff when it has received adequate funding through gifts, grants, or donations to implement this paragraph (d) (Temporary Registration Permits) and shall include in the notification the information specified in section 24-75-1303(3), C.R.S.

Temporary Registration Permit Donation Report

The Department has received two one-time donations to the License Plate Cash Fund (42-3-301(1)(a) and (b) C.R.S.), as detailed below, totaling \$506,487.00.

- \$200,000.00 was received from the E-470 Public Highway Authority on October 29, 2015
- \$306,487.00 was received from the E-470 Public Highway Authority on January 7, 2016

The ability for the Department to accept this donation was enacted with Senate Bill 15-090. This donation from E-470 Public Highway Authority is to support the manufacturing and startup of sufficient inventory of the new temporary registration permit mounting boards for the issuance of temporary registration permits by the County Clerk and Recorders on the effective date of July 1, 2016. This donation will allow the Department to purchase 468,969 temporary registration permit mounting boards which will provide the 64 County Clerks and Recorders with 7.22 months of supply.

Sustainability of the temporary registration permit program will be completed through the County Clerks and Recorders issuing the mounting boards (42-3-203(3)(a)(I), C.R.S.) purchased with this donation and by collecting a \$1.08 material fee for each mounting board issued. The material fee collected will be depositing into the License Plate Cash Fund.

The Department will complete restocking orders of the mounting boards quarterly with Colorado Correctional Industries (17-24-109.5 and 42-3-301(1)(b), C.R.S.) using the annual License Plate Cash Fund appropriation given to the Department (42-3-301(1)(b), C.R.S.) and with the funds received from the collection of the \$1.08 mounting board material fee.
