CONCERNING UPDATING THE REFERENCE TO A NATIONAL STANDARD
SETTING FORTH CERTAIN SPECIFICATIONS APPLICABLE TO THE TYPE
OF PAPER USED TO PUBLISH THE COLORADO REVISED STATUTES.

Be it enacted by the General Assembly of the State of Colorado:

SECTION 1. In Colorado Revised Statutes, **amend** 2-5-105.5 as follows:

2-5-105.5. Publication - paper specification. (1) ~~In any~~ **A** contract OR EXTENSION OF CONTRACT entered into after ~~July 1, 1991~~ **THE** EFFECTIVE DATE OF THIS SUBSECTION (1), AS AMENDED, to publish or print the Colorado Revised Statutes pursuant to section 2-5-105 ~~the contract shall~~ **MUST** specify that any ~~THE~~ paper used ~~shall be acid-free, alkaline-based, or permanent type paper that conforms to the American~~

national standards for permanent paper for printed library materials (ANSI Z39.48) MUST MEET THE ALKALINE RESERVE MINIMUM REQUIREMENTS AND ACIDITY LEVELS FOR UNCOATED PAPER ESTABLISHED BY THE AMERICAN NATIONAL STANDARDS INSTITUTE AND THE NATIONAL INFORMATION STANDARDS ORGANIZATION (ANSI/NISO Z39.48-1992 (R2009)).

(2) This provision ~~shall~~ DOES not affect any contract that is in effect on ~~July 1, 1991~~ JANUARY 1, 2017.

SECTION 2. Safety clause. The general assembly hereby finds, determines, and declares that this act is necessary for the immediate preservation of the public peace, health, and safety.


