After consideration on the merits, the Committee recommends the following:

HB18-1006 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

1 Amend reengrossed bill, page 3, strike lines 10 through 14 and substitute:

3           ~~"(b)~~ (h) Participation of persons in NEWBORN SCREENING  
4 PROGRAMS OR genetic counseling programs in this state should be wholly  
5 voluntary, and ~~that~~ all information obtained from persons involved in  
6 ~~such~~ THESE programs ~~or in newborn screening programs~~ in the state  
7 ~~should~~ MUST be held strictly confidential. FAMILY PARTICIPATION IN THE  
8 FOLLOW-UP SUPPORT".

9 Page 6, line 3, after the period add "TESTING UNDER THIS SUBSECTION  
10 (1)(b) IS NOT REQUIRED IF THE PARENT OR LEGAL GUARDIAN OBJECTS."

11 Page 6, strike lines 7 through 13 and substitute:

12           "(1.5) IF THE DEPARTMENT DEEMS THAT NEW CONDITIONS FOR  
13 WHICH AN INFANT MUST BE TESTED SHOULD BE ADDED, THE DEPARTMENT  
14 SHALL REPORT THE ADDED CONDITIONS TO THE GENERAL ASSEMBLY  
15 DURING ITS PRESENTATION IN ACCORDANCE WITH THE "STATE  
16 MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT  
17 (SMART) GOVERNMENT ACT", PART 2 OF ARTICLE 7 OF TITLE 2. THE  
18 DEPARTMENT SHALL ALSO NOTIFY THE JOINT BUDGET COMMITTEE AND THE  
19 HEALTH AND HUMAN SERVICES COMMITTEE OF THE SENATE AND THE  
20 HEALTH, INSURANCE, AND ENVIRONMENT COMMITTEE AND THE PUBLIC  
21 HEALTH CARE AND HUMAN SERVICES COMMITTEE OF THE HOUSE OF  
22 REPRESENTATIVES, OR THEIR SUCCESSOR COMMITTEES, WITHIN SIXTY

1 DAYS AFTER THE DEPARTMENT RECOMMENDS A NEW CONDITION AND  
2 INCLUDE THE ADDED CONDITIONS IN THE DEPARTMENT'S ANNUAL BUDGET  
3 REQUEST SUBMITTED TO THE GENERAL ASSEMBLY EACH NOVEMBER 1."

4 Page 10, line 10, strike "24-75-402." and substitute "24-75-402 THROUGH  
5 JULY 1, 2021."

6 Page 13, line 7, after "~~following:~~" insert "SCREENING FOR HEARING LOSS  
7 UNDER THIS SUBSECTION (3)(a) IS NOT REQUIRED IF THE PARENT OR LEGAL  
8 GUARDIAN OBJECTS."

9 Page 14, line 7, after the period add "SCREENING FOR HEARING LOSS  
10 UNDER THIS SUBSECTION (5) IS NOT REQUIRED IF THE PARENT OR LEGAL  
11 GUARDIAN OBJECTS."

12 Page 17, after line 2 insert:

13 "SECTION 7. In Colorado Revised Statutes, **amend** 25-4-1005  
14 as follows:

15 **25-4-1005. Exceptions.** Nothing in the provisions of this part 10  
16 shall be construed to require the testing or medical treatment for the  
17 minor child of any person WHO HAS PERSONAL OBJECTION TO THE  
18 ADMINISTRATION OF THE TESTS OR TREATMENT or of any person who is  
19 a member of a well-recognized church or religious denomination and  
20 whose religious convictions in accordance with the tenets or principles of  
21 ~~his~~ THE church or religious denomination are against medical treatment  
22 for disease or physical defects. ~~or has a personal objection to the~~  
23 ~~administration of such tests or treatment."~~

24 Renumber succeeding sections accordingly.

25 Page 18, strike line 1 and substitute "SCREENING PROGRAM."

26 Page 18, line 4, strike "24-75-402." and substitute "24-75-402 THROUGH  
27 JULY 1, 2021."
