13 **12-43.4-106. Marijuana delivery - repeal.**

14 (1) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE 43.4 TO THE
15 CONTRARY, A PERSON LICENSED PURSUANT TO SECTION 12-43.3-409 MAY
16 DELIVER RETAIL MARIJUANA, RETAIL MARIJUANA PRODUCTS, AND RETAIL
17 MARIJUANA CONCENTRATE PURSUANT TO THE PROVISIONS OF SECTION
18 12-43.3-409 AND ANY RULES ADOPTED PURSUANT TO SECTION
19 12-43.3-202 (2)(a)(XXIII).

20 (2) THIS SECTION IS REPEALED, EFFECTIVE DECEMBER 31, 2020.".

21 Renumber succeeding section accordingly.

22 After "PRODUCTS," add "MEDICAL MARIJUANA CONCENTRATE," on: **Page**
23 **2**, line 14; and **Page 3**, lines 3, 7, and 16.

24 Strike "AND" on: **Page 2**, line 14; and **Page 3**, lines 3, 7, and 17.

25 Strike "PRODUCTS" and substitute "PRODUCTS, AND RETAIL MARIJUANA
26 CONCENTRATE" on: **Page 2**, line 15; and **Page 3**, lines 4, 8, and 17.
