After consideration on the merits, the Committee recommends the following:

HB18-1189 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 5, after line 14 insert:
- 2 "(6) "FUND" MEANS THE TEACHER RESIDENCY EXPANSION
- 3 PROGRAM FUND CREATED IN SECTION 22-60.3-106."

- 4 Renumber succeeding subsections accordingly.

- 5 Page 8, strike lines 6 and 7 substitute "SHALL CONTRACT WITH UP TO
- 6 THREE INSTITUTIONS OF HIGHER EDUCATION AND UP TO THREE
- 7 ALTERNATIVE TEACHER PROGRAMS, EACH OF WHICH OPERATES A
- 8 PROVEN".

- 9 Page 8, line 11, strike "PROGRAM," and substitute "PROGRAMS,".

- 10 Page 9, line 9, strike "THE" and substitute "EACH".

- 11 Page 9, line 10, strike "ENTER" and substitute "ENTERS".

- 12 Page 11, after line 9 insert:
- 13 "**22-60.3-106. Teacher residency expansion program fund -**
- 14 **created.** (1) THE TEACHER RESIDENCY EXPANSION PROGRAM FUND IS
- 15 HEREBY CREATED IN THE STATE TREASURY. THE FUND CONSISTS OF
- 16 MONEY THAT THE GENERAL ASSEMBLY MAY APPROPRIATE OR TRANSFER
- 17 TO THE FUND. THE STATE TREASURER SHALL CREDIT ALL INTEREST AND
- 18 INCOME DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEY IN THE
- 19 FUND TO THE FUND.

1 (2) MONEY IN THE FUND IS CONTINUOUSLY APPROPRIATED TO THE
2 DEPARTMENT FOR USE IN IMPLEMENTING THE PROGRAM.

3 (3) THE STATE TREASURER SHALL TRANSFER ALL UNEXPENDED
4 AND UNENCUMBERED MONEY IN THE FUND ON JULY 1, 2023, TO THE
5 GENERAL FUND."

6 Renumber succeeding statutory section accordingly.

7 Strike "INSTITUTION" and substitute "INSTITUTIONS" on: **Page 8**, lines 10
8 and 18; and **Page 9**, line 6.

9 Strike "PROGRAM" and substitute "PROGRAMS" on: **Page 8**, line 19; and
10 **Page 9**, line 7.
