After consideration on the merits, the Committee recommends the following:

SB18-223 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, page 4, line 13, after "A" insert "STATE CHILD
2 FATALITY PREVENTION REVIEW TEAM ESTABLISHED PURSUANT TO SECTION
3 25-20.5-406 OR A".

4 Page 4, line 15, after "THE" insert "APPLICABLE".

5 Page 5, line 1, strike "RESIDENTIAL".

6 Page 5, after line 1 insert:

7 "(X) A HEALTH CARE FACILITY THAT IS LICENSED OR CERTIFIED IN
8 ACCORDANCE WITH THE REQUIREMENTS OF ARTICLE 3 OF TITLE 25 AT
9 WHICH FACILITY THE DECEASED HAD PREVIOUSLY RECEIVED
10 TREATMENT;"

11 Renumber succeeding subparagraphs accordingly.

12 Page 5, line 7, strike "OR".

13 Page 5, line 12, strike "APPLICABLE." and substitute "APPLICABLE;

14 (XIV) THE COLORADO DEPARTMENT OF HUMAN SERVICES IN
15 CONNECTION WITH THE INVESTIGATION OF A FATALITY THAT HAS
16 OCCURRED WITHIN ANY FACILITY THAT IS LICENSED UNDER THE "CHILD
17 CARE LICENSING ACT", PART 1 OF ARTICLE 6 OF TITLE 26;

1 (XV) THE OFFICE OF THE CHILD PROTECTION OMBUDSMAN
2 ESTABLISHED IN SECTION 19-3.3-102 (1)(a); OR
3 (XVI) A HEALTH CARE PROVIDER LICENSED IN ACCORDANCE WITH
4 THE REQUIREMENTS OF TITLE 12 THAT HAD PREVIOUSLY ESTABLISHED A
5 PATIENT-PROVIDER RELATIONSHIP WITH THE DECEASED.
6 (3) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION,
7 IN A CASE IN WHICH THE INFORMATION CONTAINED IN AN AUTOPSY REPORT
8 IS ESSENTIAL TO A PERSON, AGENCY, OR ORGANIZATION IN CONDUCTING
9 A BONA FIDE RESEARCH PROJECT, THE PERSON, AGENCY, OR
10 ORGANIZATION MAY OBTAIN ACCESS TO THE REPORT WHERE SUCH ACCESS
11 IS AUTHORIZED BY A COURT FOR GOOD CAUSE."
