20 TWO HUNDRED THIRTY-ONE dollars in district court cases at the time the
21 demand is made pursuant to the Colorado rules of civil procedure.

33 **SECTION 8. Appropriation.** For the 2019-20 state fiscal year,
34 \$835,386 is appropriated to the judicial department for use by the office
35 of public guardianship. Of this appropriation, \$427,000 is from the
36 general fund and \$408,386 is from the office of public guardianship cash
37 fund created in section 13-94-108 (1), C.R.S. The appropriation is based
38 on an assumption that the office will require an additional 4.5 FTE. The
39 office may use this appropriation for operation of a pilot implementation
40 of article 94 of title 13, C.R.S., in the second judicial district.

41 **SECTION 9. Effective date - applicability.** This act takes effect

1 July 1, 2019, and applies to fees assessed on or after said date.
2 **SECTION 10. Safety clause.** The general assembly hereby finds,
3 determines, and declares that this act is necessary for the immediate
4 preservation of the public peace, health, and safety."."
