Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB19-1250 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 6, strike lines 2 through 9 and substitute:

2 "SECTION 8. In Colorado Revised Statutes, **add** 17-18-127 as  
3 follows:

4 **17-18-127. Appropriation to comply with section 2-2-703 -**  
5 **H.B. 19-1250 - repeal.** (1) PURSUANT TO SECTION 2-2-703, THE  
6 FOLLOWING STATUTORY APPROPRIATIONS ARE MADE IN ORDER TO  
7 IMPLEMENT HOUSE BILL 19-1250, ENACTED IN 2019:

8 (a) FOR THE 2019-20 STATE FISCAL YEAR, ONE HUNDRED SEVENTY-  
9 EIGHT THOUSAND FOUR HUNDRED SEVENTY-ONE DOLLARS IS  
10 APPROPRIATED FROM THE CAPITAL CONSTRUCTION FUND CREATED IN  
11 SECTION 24-75-302, TO THE CORRECTIONS EXPANSION RESERVE FUND  
12 CREATED IN SECTION 17-1-116.

13 (b) FOR THE 2020-21 STATE FISCAL YEAR, THIRTY-NINE THOUSAND  
14 SEVEN HUNDRED ONE DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
15 FROM THE GENERAL FUND.

16 (c) FOR THE 2021-22 STATE FISCAL YEAR, FORTY-THREE THOUSAND  
17 NINE HUNDRED SIXTEEN DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
18 FROM THE GENERAL FUND.

19 (d) FOR THE 2022-23 STATE FISCAL YEAR, FORTY-THREE THOUSAND  
20 THREE HUNDRED ELEVEN DOLLARS IS APPROPRIATED TO THE DEPARTMENT  
21 FROM THE GENERAL FUND.

22 (e) FOR THE 2023-24 STATE FISCAL YEAR, FORTY-ONE THOUSAND  
23 FOUR HUNDRED NINETY-ONE DOLLARS IS APPROPRIATED TO THE

1 DEPARTMENT FROM THE GENERAL FUND.

2 (2) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2024.

3 **SECTION 9.** In Colorado Revised Statutes, 24-75-302, **add**

4 (2)(gg) as follows:

5 **24-75-302. Capital construction fund - capital assessment fees**  
6 **- calculation - information technology capital account - repeal.**

7 (2) The controller shall transfer a sum as specified in this subsection (2)  
8 from the general fund to the capital construction fund as moneys become  
9 available in the general fund during the fiscal year beginning on July 1 of  
10 the fiscal year in which the transfer is made. Transfers between funds  
11 pursuant to this subsection (2) are not appropriations subject to the  
12 limitations of section 24-75-201.1. The amounts transferred pursuant to  
13 this subsection (2) are as follows:

14 (gg) FOR THE 2019-20 FISCAL YEAR, ONE HUNDRED SEVENTY-  
15 EIGHT THOUSAND FOUR HUNDRED SEVENTY-ONE DOLLARS PURSUANT TO  
16 H.B. 19-1250, ENACTED IN 2019."

17 Renumber succeeding sections accordingly.

18 Page 1, line 101, strike "OFFICER." and substitute "OFFICER, AND, IN  
19 CONNECTION THEREWITH, MAKING AN APPROPRIATION."
