CONCERNING CHANGES TO THE JOINT RULES OF THE SENATE AND HOUSE OF REPRESENTATIVES REGARDING OVERSIGHT RESPONSIBILITIES OF COMMITTEES OF REFERENCE.

Be It Resolved by the House of Representatives of the Seventy-second General Assembly of the State of Colorado, the Senate concurring herein:

That in the Joint Rules of the Senate and House of Representatives, Joint Rule No. 25, **amend** (b) and (e)(2)(A) as follows:

25. Oversight Responsibilities of Committees of Reference and Statutory Committees

- (b) For purposes of implementing subsection (a) of this joint rule, the division of responsibilities of the principal departments and agencies among House and Senate committees of reference shall be as follows; except that the listing of a department in this subsection (b) shall not prevent any House or Senate committee of reference, the Capital Development Committee, or the Joint Technology Committee from requesting or receiving information concerning a division, section, office, agency, or specific operation or program within the subject-matter jurisdiction of the specified committee:






