After consideration on the merits, the Committee recommends the following:

HB20-1194 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 11, strike "BUT PRIOR TO JANUARY 1,  
2 2025,".

3 Page 2, strike lines 20 through 23.

4 Page 3, strike lines 1 through 5 and substitute:

5 "January 1 of the ~~sixth~~ income tax year following the year in which the  
6 executive director files written certification with the revisor of statutes ~~as~~  
7 ~~specified in section 39-22-1001 (8) that a line has become available and~~  
8 THAT the American Red Cross Colorado disaster response, readiness, and  
9 preparedness fund voluntary contribution is ~~next in the queue, unless the~~  
10 ~~voluntary contribution to the American Red Cross Colorado disaster~~  
11 ~~response, readiness, and preparedness fund established by this part 43 is~~  
12 ~~continued or reestablished by the general assembly acting by a bill prior~~  
13 ~~to said date~~ WILL NO LONGER APPEAR ON THE INDIVIDUAL INCOME TAX  
14 RETURN FORM DUE TO A FAILURE TO MEET STATUTORY REQUIREMENTS.

15 **SECTION 3.** In Colorado Revised Statutes, 39-22-1001, **amend**  
16 (1)(b) as follows:

17 **39-22-1001. Limitations on voluntary contribution programs**  
18 **- queue - notice - reestablishment of certain programs.** (1) (b) There  
19 shall be no requirement for a sunset clause for the homeless prevention  
20 activities program fund voluntary contribution established in part 13 of  
21 this article 22, the western slope military veterans' cemetery voluntary

1 contribution established in part 19 of this article 22, THE AMERICAN RED  
2 CROSS COLORADO DISASTER RESPONSE, READINESS, AND PREPAREDNESS  
3 FUND VOLUNTARY CONTRIBUTION ESTABLISHED IN PART 43 OF THIS  
4 ARTICLE 22, or the donate to a Colorado nonprofit fund voluntary  
5 contribution established in part 51 of this article 22. All other voluntary  
6 contribution programs shall remain on Colorado income tax returns for  
7 the income tax years specified in the part in which the voluntary  
8 contribution is established and shall be repealed or reestablished as  
9 directed in such part."

10 Renumber succeeding section accordingly.
