After consideration on the merits, the Committee recommends the following:

SB20-003 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend reengrossed bill, page 4, line 3, strike "2019-20 STATE FISCAL  
2 YEAR, SIX" and substitute "2020-21 STATE FISCAL YEAR, ONE".

3 Page 4, strike lines 5 through 17 and substitute:

4 "SECTION 4. In Colorado Revised Statutes, add 33-9-113 as  
5 follows:

6 **33-9-113. Parks and wildlife commission duties - gifts, grants,  
7 and donations for Fishers Peak State Park - funding needs reporting  
8 - repeal** (1) THE COMMISSION SHALL SEEK, ACCEPT, AND EXPEND GIFTS,  
9 GRANTS, OR DONATIONS FROM PRIVATE OR PUBLIC SOURCES FOR THE  
10 PURPOSES OF DEVELOPING AND IMPROVING FISHERS PEAK STATE PARK.

11 (2) BY DECEMBER 1, 2020, THE COMMISSION SHALL SUBMIT A  
12 REPORT TO THE GENERAL ASSEMBLY DETAILING STATE PARK FUNDING  
13 NEEDS AND SHORTFALLS.

14 (3) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2024.

15 **SECTION 5. Capital construction appropriation.** (1) To  
16 implement this act, the general fund appropriation made in the annual  
17 general appropriation act for the 2020-21 state fiscal year to the  
18 governor's office for use by the office of information technology for  
19 applications administration is decreased by \$1,000,000.

20 (2) For the 2020-21 state fiscal year, \$1,000,000 is appropriated  
21 to the department of natural resources for use by the division of parks and  
22 wildlife. This appropriation is from the capital construction fund created  
23 in section 24-75-302, C.R.S. To implement this act, the division of parks

1 and wildlife may use this appropriation for capital construction related to  
2 infrastructure development projects, including conducting any necessary  
3 cultural and natural resource studies, at the new Fishers Peak State Park  
4 in Las Animas county.

5 (3) The appropriation made in subsection (2) of this section is  
6 available for state fiscal year 2020-21, and if any appropriation project  
7 is".
