After consideration on the merits, the Committee recommends the following:

SB20-035 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend reengrossed bill, page 2, line 3, after "(6)" insert "and (7)".
- 2 Page 2, line 9, after the period insert "THE KIOSK PROGRAM MAY INCLUDE
- 3 MOBILE TELEPHONE AND WEB SOLUTIONS TO PROVIDE SERVICES."
- 4 Page 2, line 10, strike "MAY AND IS ENCOURAGED TO:" and substitute
- 5 "SHALL:".
- 6 Page 2, line 13, strike "OR" and substitute "AND".
- 7 Page 2, line 17, strike "fee" and substitute "fee,".
- 8 Page 2, line 18, strike "~~dollars~~," and substitute "~~dollars~~ AS NEGOTIATED
- 9 BETWEEN THE AUTHORIZED AGENT AND THE PRIVATE PROVIDER,".
- 10 Page 3, strike lines 11 through 23 and substitute:
11 "(6) TO BE QUALIFIED TO BE A PRIVATE PROVIDER, A PERSON MUST:
12 (a) MEET THE SECURITY REQUIREMENTS ESTABLISHED BY RULE BY
13 THE OFFICE OF INFORMATION TECHNOLOGY; AND
14 (b) OPERATE IN ACCORDANCE WITH A SERVICE-LEVEL AGREEMENT
15 WITH THE AUTHORIZED AGENT."
- 16 Page 3, after line 23 insert:

1 "(7) (a) THE PRIVATE PROVIDER SHALL NOT RETAIN THE
2 INFORMATION OBTAINED FROM A TRANSACTION AUTHORIZED UNDER THIS
3 SECTION FOR ANY PURPOSE OTHER THAN THE PURPOSES OF THIS SECTION
4 AND AS REQUIRED IN THE SERVICE-LEVEL AGREEMENT WITH THE
5 AUTHORIZED AGENT.

6 (b) THE PRIVATE PROVIDER SHALL NOT TRANSFER TO ANOTHER
7 PERSON OR USE OR COPY INFORMATION OBTAINED FROM A TRANSACTION
8 AUTHORIZED UNDER THIS SECTION FOR ANY PURPOSE OTHER THAN THE
9 PURPOSES OF THIS SECTION AND AS REQUIRED IN THE SERVICE-LEVEL
10 AGREEMENT WITH THE AUTHORIZED AGENT."

11 Page 4, strike lines 3 through 12 and substitute:

12 "**SECTION 3. Safety clause.** The general assembly hereby finds,
13 determines, and declares that this act is necessary for the immediate
14 preservation of the public peace, health, or safety."
