After consideration on the merits, the Committee recommends the following:

SB20-200 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend reengrossed bill, page 6, line 16, strike "JULY 1," and substitute
2 "SEPTEMBER 15," and strike "JUNE 30," and substitute "SEPTEMBER 14,".

3 Page 6, line 18, strike "JULY 1," and substitute "SEPTEMBER 15,".

4 Page 6, line 19, strike "JULY 1," and substitute "SEPTEMBER 15,".

5 Page 15, line 26, strike "BOARD." and substitute "BOARD, AND ANY GIFTS,
6 GRANTS, DONATIONS, OR INVESTMENTS RECEIVED BY THE STATE
7 TREASURER.".

8 Page 16, strike lines 8 through 13 and substitute:
9 **"24-54.3-109. Implementation and administration - costs.** THE
10 STATE TREASURER MAY SEEK, ACCEPT, AND EXPEND GIFTS, GRANTS,
11 DONATIONS, OR INVESTMENTS NOT REQUIRED TO BE REPAYED, FROM
12 PRIVATE OR PUBLIC SOURCES FOR THE COSTS ASSOCIATED WITH THE
13 ADMINISTRATION OF THIS ARTICLE 54.3.".

14 Page 17, after line 15 insert:
15 **"SECTION 9. Appropriation - adjustments to 2020 long bill.**
16 To implement this act, the general fund appropriation made in the annual
17 general appropriation act for the 2020-21 state fiscal year to the office of
18 the governor for use by the office of information technology for
19 applications administration is decreased by \$1,197,552.

1 **SECTION 10. Appropriation.** (1) For the 2020-21 state fiscal
2 year, \$1,197,552 is appropriated to the department of the treasury. This
3 appropriation is from the general fund. Any money appropriated in this
4 section not expended prior to July 1, 2021, is further appropriated to the
5 department for the 2021-22 state fiscal year for the same purpose. To
6 implement this act, the department may use this appropriation as follows:
7 (a) \$1,133,592 for the Colorado secure savings program, which
8 amount is based on an assumption that the department will require an
9 additional 5.0 FTE; and
10 (b) \$63,960 for the purchase of legal services.
11 (2) For the 2020-21 state fiscal year, \$63,960 is appropriated to the
12 department of law. This appropriation is from reappropriated funds
13 received from the department of the treasury under subsection (1)(b) of
14 this section and is based on an assumption that the department of law will
15 require an additional 0.3 FTE. To implement this act, the department of
16 law may use this appropriation to provide legal services for the
17 department of the treasury."

18 Page 17, strike lines 16 through 25 and substitute:

19 **"SECTION 11. Safety clause.** The general assembly hereby
20 finds, determines, and declares that this act is necessary for the immediate
21 preservation of the public peace, health, or safety."

22 Page 1, line 103, strike "WORKERS." and substitute "WORKERS, AND, IN
23 CONNECTION THEREWITH, MAKING AND REDUCING AN
24 APPROPRIATION."
