After consideration on the merits, the Committee recommends the following:

HB21-1102 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 2, strike lines 2 through 20.
- 2 Page 3, strike lines 1 through 10.
- 3 Renumber succeeding sections accordingly.
- 4 Page 4, strike lines 16 through 20 and substitute:
 - 5 "(3) (a) A PET STORE THAT WAS LICENSED BY THE COMMISSIONER
 - 6 PRIOR TO THE EFFECTIVE DATE OF THIS SECTION TO SELL OR OFFER FOR
 - 7 SALE DOGS OR CATS MAY CONTINUE TO SELL OR OFFER FOR SALE DOGS OR
 - 8 CATS ON OR AFTER THE EFFECTIVE DATE OF THIS SECTION:
 - 9 (I) FROM THE SAME LOCATION, WHETHER UNDER THE CURRENT
 - 10 OWNER OR UNDER CHANGED OWNERSHIP; OR
 - 11 (II) FROM A NEW LOCATION THAT REPLACES THE EXISTING
 - 12 LOCATION, WHETHER UNDER THE CURRENT OWNER OR UNDER CHANGED
 - 13 OWNERSHIP.
 - 14 (b) THE PET STORE SHALL:".
- 15 Page 4, line 21, strike "(a)" and substitute "(I)".
- 16 Page 4, line 25, strike "(b)" and substitute "(II)".
- 17 Page 5, line 3, strike "(c)" and substitute "(III)".

1 Page 5, line 6, strike "(I)" and substitute "(A)".

2 Page 5, line 7, strike "(II)" and substitute "(B)".

3 Page 5, line 10, strike "(III)" and substitute "(C)".

4 Page 5, after line 13 insert:

5 "(4) ON AND AFTER THE EFFECTIVE DATE OF THIS SECTION, THE
6 NUMBER OF PET STORES AUTHORIZED TO SELL OR OFFER FOR SALE DOGS OR
7 CATS MUST NOT EXCEED THE NUMBER OF PET STORES THAT WERE
8 AUTHORIZED TO SELL OR OFFER FOR SALE DOGS OR CATS ON THE DAY
9 BEFORE THE EFFECTIVE DATE OF THIS SECTION."

10 Renumber succeeding subsection accordingly.

11 Printed bill, page 5, strikes lines 18 through 22 and substitute:

12 "SECTION 3. Act subject to petition - effective date -
13 applicability. (1) This act takes effect at 12:01 a.m. on the day following
14 the expiration of the ninety-day period after final adjournment of the
15 general assembly; except that, if a referendum petition is filed pursuant
16 to section 1 (3) of article V of the state constitution against this act or an
17 item, section, or part of this act within such period, then the act, item,
18 section, or part will not take effect unless approved by the people at the
19 general election to be held in November 2022 and, in such case, will take
20 effect on the date of the official declaration of the vote thereon by the
21 governor.

22 (2) This act applies to conduct occurring on or after the applicable
23 effective date of this act."
