After consideration on the merits, the Committee recommends the following:

HB21-1132 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

1 Amend printed bill, page 5, strike lines 25 through 27 and substitute
2 "PRIORITIZED FOR ELIGIBLE LOCAL GOVERNMENTAL ENTITIES THAT ARE
3 COUNTIES WITH LOWER PROPERTY VALUES COMPARED TO THE PROPERTY
4 VALUES OF ALL COUNTIES THAT ARE ELIGIBLE LOCAL GOVERNMENTAL
5 ENTITIES OR PRIORITIZED FOR ELIGIBLE LOCAL GOVERNMENTAL ENTITIES
6 LOCATED IN COUNTIES WITH LOWER PROPERTY VALUES COMPARED TO THE
7 PROPERTY VALUES OF ALL COUNTIES THAT ARE ELIGIBLE LOCAL
8 GOVERNMENTAL ENTITIES. IF AN ELIGIBLE LOCAL GOVERNMENTAL ENTITY
9 HAS A JURISDICTIONAL BOUNDARY THAT INCLUDES MORE THAN ONE
10 COUNTY, THEN THE PRIORITIZATION FOR THAT ELIGIBLE LOCAL
11 GOVERNMENTAL ENTITY IS ESTABLISHED BASED ON THE COUNTY IN WHICH
12 THE ELIGIBLE LOCAL GOVERNMENTAL ENTITY'S ADMINISTRATIVE OFFICES
13 ARE LOCATED. At the end of any fiscal year, all".

14 Page 8, strike lines 11 through 13 and substitute "PRIORITIZATION
15 REQUIREMENTS SET FORTH IN SUBSECTION (2)(a) OF THIS SECTION."

16 Page 8, strike lines 25 through 27 and substitute:
17 "(c) TO ASCERTAIN THE PROPERTY VALUES FOR EACH COUNTY
18 THAT IS AN ELIGIBLE LOCAL GOVERNMENTAL ENTITY AND COMPARE THAT
19 TO THE PROPERTY VALUES FOR ALL COUNTIES THAT ARE ELIGIBLE LOCAL
20 GOVERNMENTAL ENTITIES."

21 Page 9, strike line 5 and substitute "PRIORITIZATION REQUIREMENTS SET
22 FORTH IN SECTION 44-30-1301 (2)(a);".
