

1 PURPOSE OF THIS SECTION, "BONA FIDE AGRICULTURAL PRODUCER" MEANS
2 AN AGRICULTURAL PRODUCER THAT RECEIVES A MAJORITY OF THE
3 PRODUCER'S ANNUAL INCOME FROM AGRICULTURE, AN AGRICULTURAL
4 PRODUCER THAT SPENDS MORE THAN ONE THOUSAND FORTY HOURS PER
5 YEAR ENGAGED IN AGRICULTURAL PRODUCTION, OR A COLORADO
6 BUSINESS THAT PROCESSES AGRICULTURAL PRODUCTS. EXCEPT FOR A
7 PROGRAM OR SUPPORT ADMINISTERED BY THE OFFICE TO ADDRESS
8 IMMEDIATE NEEDS AS A RESULT OF DISASTER, INCLUDING WILDFIRE AND
9 DROUGHT, OR A PROGRAM THAT WAS IN EXISTENCE ON JANUARY 1, 2021:
10 (a) A PROGRAM ADMINISTERED BY THE OFFICE MUST BE DESIGNED
11 TO BENEFIT BONA FIDE AGRICULTURAL PRODUCERS ACTIVELY ENGAGED
12 IN AGRICULTURE. GRANTS AWARDED BY THE OFFICE MUST PAY FOR
13 IMPLEMENTATION OF PRACTICES TO ADDRESS AND MITIGATE THE IMPACTS
14 OF CLIMATE CHANGE OR DROUGHT OR TO PROVIDE DIRECT ADAPTATION
15 SUPPORT FOR IMPACTED AGRICULTURAL COMMUNITIES, INCLUDING
16 MENTAL HEALTH RESOURCES, CONFLICT RESOLUTION ASSISTANCE, AND
17 RISK-MANAGEMENT GUIDANCE. A GRANT AWARD MAY PAY NO MORE THAN
18 FIVE PERCENT OF ADMINISTRATIVE EXPENSES INCURRED BY A BONA FIDE
19 AGRICULTURAL PRODUCER TO IMPLEMENT THE PRACTICES.
20 (b) THE DEPARTMENT SHALL, AT LEAST THIRTY DAYS BEFORE
21 OPENING THE GRANT APPLICATION PROCESS, MAKE AVAILABLE ON ITS
22 WEBSITE INFORMATION RELATED TO THE GRANT PROGRAM AVAILABLE TO
23 BONE FIDE AGRICULTURAL PRODUCERS;
24 (c) A GRANT AUTHORIZED PURSUANT TO THIS SECTION MUST
25 RECEIVE FINAL APPROVAL BY THE COMMISSION BEFORE A FINAL AWARD
26 CAN BE ISSUED; AND
27 (d) THE DEPARTMENT SHALL POST ON ITS WEBSITE ALL
28 APPLICATIONS FOR GRANT AWARDS. WITHIN FIFTEEN DAYS AFTER
29 AWARDED A GRANT, THE DEPARTMENT SHALL POST ON ITS WEBSITE THE
30 NAME OF THE INDIVIDUAL OR ENTITY RECEIVING A GRANT, THE AMOUNT
31 OF THE GRANT AWARDED, THE PROJECT OR PROJECTS TO BE FUNDED BY
32 THE GRANT, AND THE DURATION OF THE GRANT AWARD."

33 Page 4, strike line 6 and substitute:

34 "(d) THE DEPARTMENT SHALL:
35 (I) REPORT AND REGULARLY UPDATE ON ITS WEBSITE THE AMOUNT
36 AND SOURCE OF MONEY RECEIVED UNDER THIS SUBSECTION (4) AND, IF
37 THE MONEY IS A GIFT, GRANT, OR DONATION, THE PURPOSE AND PERIOD OF
38 TIME FOR WHICH THE MONEY IS AVAILABLE; AND
39 (II) REPORT ANNUALLY THE AMOUNT AND".



1 Page 4, line 10, strike "2." and substitute "2 AND, IF THE MONEY IS A GIFT,
2 GRANT, OR DONATION, THE NAME OF THE SOURCE OF THE MONEY AND THE
3 GRANTEE."
