<u>HB21-1294</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

Amend the Education Committee Report, dated May 6, 2021, page 1,
 after line 2, insert:

3 "Page 6 of the bill, strike lines 1 through 14 and substitute:

4 "(c) WHETHER AND TO WHAT EXTENT UNINTENDED BARRIERS OR
5 OBSTACLES EXIST THAT INADVERTENTLY IMPACT THE PERFORMANCE OF
6 STUDENTS FROM DIFFERENT RACIAL, ETHNIC, SOCIOECONOMIC, OR
7 DISABILITY COMMUNITIES, AS MEASURED BY THE STATEWIDE SYSTEM OF
8 STANDARDS AND ASSESSMENTS AND THE STATEWIDE EDUCATION
9 ACCOUNTABILITY SYSTEM, INCLUDING HOW THESE SYSTEMS ARE
10 IMPLEMENTED BY SCHOOLS AND SCHOOL DISTRICTS;".".

11 Page 1 of the committee report, strike lines 10 through 19 and substitute:

""(b) NO LATER THAN JANUARY 15, 2022, THE STATE AUDITOR,
THE CONTRACTOR, AND THE DEPARTMENT OF EDUCATION SHALL ENTER
INTO A DATA SHARING AGREEMENT FOR AUDIT PURPOSES IN A FORM
CONSISTENT WITH 34 C.F.R. 99.35(a)(3) AND IN COMPLIANCE WITH THE
FEDERAL "FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974", 20
U.S.C. SEC. 1232G, AS AMENDED.".".

18 Strike page 2 of the committee report and substitute:



1 "Page 10 of the bill, strike lines 1 through 3.

Page 10 of the bill, line 18, strike "EDUCATION," and substitute
"EDUCATION AND ARE NOT AVAILABLE FROM OTHER SOURCES AS
DETERMINED BY THE STATE AUDITOR'S AND CONTRACTOR'S GOOD FAITH
EFFORTS TO OBTAIN THEM FROM OTHER SOURCES,".

6 Page 13 of the bill, after line 12 insert:

7 "SECTION 4. Appropriation. (1) For the 2021-22 state fiscal 8 year, \$300,000 is appropriated to the legislative department for use by the office of the state auditor. This appropriation is from the general fund. To 9 implement this act, the office of the state auditor may use this 10 appropriation for the audit of statewide education accountability systems. 11 (2) For the 2021-22 state fiscal year, \$52,000 is appropriated to 12 the department of education. This appropriation is from the general fund. 13 14 To implement this act, the department may use this appropriation for information technology services.". 15

- 17 Page 1 of the bill, line 103, strike "STATE." and substitute "STATE, AND,
- 18 IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.".".
