After consideration on the merits, the Committee recommends the following:

SB21-025 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 4, strike lines 6 through 9 and substitute:
2 "(a) "ELIGIBLE INDIVIDUAL" MEANS AN INDIVIDUAL WHO IS NOT
3 PREGNANT AND WHOSE INCOME DOES NOT EXCEED THE STATE'S CURRENT
4 EFFECTIVE INCOME LEVEL FOR PREGNANT WOMEN UNDER THE CHILDREN'S
5 BASIC HEALTH PLAN ESTABLISHED PURSUANT TO ARTICLE 8 OF TITLE 25.5,
6 AND WHOSE INCOME IS ADJUSTED FOR FAMILY SIZE BASED ON THE
7 METHODOLOGY ALLOWED UNDER FEDERAL LAW TO COUNT THE APPLICANT
8 AS A HOUSEHOLD OF TWO IN ADDITION TO ANY OTHER HOUSEHOLD
9 MEMBERS, AND WHO MEETS OTHER REQUIREMENTS UNDER FEDERAL
10 LAW."
- 11 Page 4, line 10, strike "INCLUDES:" and substitute "INCLUDES, AS
12 PERMITTED UNDER FEDERAL LAW:".
- 13 Page 4, strike line 21 and substitute:
14 "(VI) BASIC FERTILITY TESTING;".
- 15 Page 4, strike lines 22 through 24 and substitute:
16 "(VII) DIAGNOSIS OR TREATMENT OF A SEXUALLY TRANSMITTED
17 INFECTION OR SEXUALLY TRANSMITTED DISEASE, OR MEDICATION TO
18 PREVENT A SEXUALLY TRANSMITTED INFECTION OR SEXUALLY
19 TRANSMITTED DISEASE, THAT IS PROVIDED PURSUANT TO A FAMILY
20 PLANNING VISIT; AND
21 (VIII) ANY OTHER MEDICAL DIAGNOSIS, TREATMENT, OR

1 PREVENTIVE SERVICE THAT IS ROUTINELY PROVIDED PURSUANT TO A
2 FAMILY PLANNING VISIT."

3 Page 5, line 11, strike "IF REQUESTED" and substitute "UNLESS
4 REQUESTED OTHERWISE".

5 Page 5, line 12, strike "UP TO".

6 Page 5, line 13, strike "CONTRACEPTION" and substitute
7 "SELF-ADMINISTERED HORMONAL CONTRACEPTIVES".

8 Page 1, lines 102 and 103, strike "TWO HUNDRED FIFTY PERCENT OF THE
9 FEDERAL POVERTY LEVEL." and substitute "THE STATE'S CURRENT
10 EFFECTIVE INCOME LEVEL FOR PREGNANT WOMEN UNDER THE
11 CHILDREN'S BASIC HEALTH PLAN."
