After consideration on the merits, the Committee recommends the following:

HB22-1297 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, strike lines 19 through 24 and substitute:

2 "(b) (I) THIS SUBSECTION (2.5) TAKES EFFECT AT TWO O'CLOCK
3 ANTEMERIDIAN ON THE FIRST SUNDAY OF NOVEMBER AFTER THE
4 GOVERNOR NOTIFIES THE REVISOR OF STATUTES THAT THE FOLLOWING
5 CONDITIONS HAVE OCCURRED:

6 (A) A FEDERAL LAW IS ENACTED AND TAKES EFFECT THAT
7 AUTHORIZES STATES TO ADOPT COORDINATED UNIVERSAL TIME MINUS SIX
8 HOURS, COMMONLY KNOWN AS "UNITED STATES MOUNTAIN DAYLIGHT
9 SAVING TIME", AS THE STANDARD TIME FOR THE STATE THROUGHOUT THE
10 YEAR; AND

11 (B) AT LEAST FOUR STATES IN THE MOUNTAIN STANDARD TIME
12 ZONE, IN ADDITION TO COLORADO, ENACT LEGISLATION THAT BECOMES
13 LAW MAKING COORDINATED UNIVERSAL TIME MINUS SIX HOURS,
14 COMMONLY KNOWN AS "UNITED STATES MOUNTAIN DAYLIGHT SAVING
15 TIME", THE STATES' STANDARD TIME THROUGHOUT THE YEAR.

16 (II) THE GOVERNOR SHALL NOTIFY THE REVISOR OF STATUTES IN
17 WRITING OF THE DATE ON WHICH THE CONDITIONS SPECIFIED IN
18 SUBSECTION (2.5)(b)(I) OF THIS SECTION HAVE OCCURRED BY E-MAILING
19 THE NOTICE TO REVISOROFSTATUTES.GA@STATE.CO.US.

20 (III) FOR PURPOSES OF THIS SUBSECTION (2.5)(b), THE MOUNTAIN
21 STANDARD TIME ZONE INCLUDES ARIZONA, NEW MEXICO, COLORADO,
22 UTAH, WYOMING, MONTANA, AND THE SOUTHERN PORTION OF IDAHO AS
23 DESCRIBED IN 15 U.S.C. SEC. 264."
