Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB22-154 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the Health and Human Services Committee Report, dated April
2 4, 2022, page 2, after line 11 insert:

3 "Page 7 of the bill, line 3, after the period insert "AN APPEAL TO THE
4 EXECUTIVE DIRECTOR OF THE DEPARTMENT MUST BE FILED WITHIN FIVE
5 BUSINESS DAYS AFTER THE RESIDENT OR PERSON FILING THE GRIEVANCE
6 RECEIVES THE DESIGNEE'S WRITTEN RESPONSE."."

7 Page 2 of the committee report, line 21, strike "2023," and substitute
8 "2024,".

9 Page 3 of the committee report, strike lines 18 through 21 and substitute:

10 "Page 10 of the bill, strike lines 9 and 10 and substitute:

11 "(E) Paying a civil fine not to exceed ~~two thousand dollars in a~~
12 ~~calendar year~~ FIFTEEN THOUSAND DOLLARS PER VIOLATION; EXCEPT THAT
13 THE DEPARTMENT MAY EXCEED THE CAP FOR AN EGREGIOUS VIOLATION
14 THAT RESULTS IN DEATH OR SERIOUS INJURY TO A RESIDENT AFTER
15 CONSIDERING THE CIRCUMSTANCES SURROUNDING THE VIOLATION AND
16 THE FACTORS SET FORTH IN SUBSECTION (4)(a) OF THIS SECTION."."

17 Amend printed bill, page 12, after line 20 insert:

18 "**SECTION 5. Appropriation.** (1) For the 2022-23 state fiscal
19 year, \$74,509 is appropriated to the department of public health and
20 environment. This appropriation is from the general fund. To implement
21 this act, the department may use this appropriation as follows:

1 (a) \$26,829 for use by the health facilities and emergency medical
2 services division for administration and operations, which amount is
3 based on an assumption that the division will require an additional 0.3
4 FTE; and

5 (b) \$47,680 for the purchase of information technology services.

6 (2) For the 2022-23 state fiscal year, \$47,680 is appropriated to
7 the office of the governor for use by the office of information technology.
8 This appropriation is from reappropriated funds received from the
9 department of public health and environment under subsection (1)(b) of
10 this section. To implement this act, the office may use this appropriation
11 to provide information technology services for the department of public
12 health and environment."

13 Renumber succeeding section accordingly.

14 Page 1, line 101 strike "**RESIDENCES.**" and substitute "**RESIDENCES, AND,**
15 **IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
