Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB23-1008 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Finance Committee Report, dated February 13, 2023, page 1,
- 2 strike lines 1 and 2 and substitute:
 - 3 "Amend printed bill, page 3, strike lines 20 through 27.
 - 4 Page 4 of the printed bill, strike lines 1 through 17.
 - 5 Renumber succeeding sections accordingly.
 - 6 Page 5 of the printed bill, line 15, after "**equipment** - " insert
 - 7 "**community food consortium duties and responsibilities** - ".".
 - 8 Page 1 of the report, line 12, strike "PALLET." and substitute "PALLET,".
 - 9 Page 5 of the report, strike lines 10 through 12 and substitute:
 - 10 "Page 10 of the printed bill, strike lines 2 and 3 and substitute:
 - 11 "**SECTION 5.** In Colorado Revised Statutes, 35-1-117, **amend**
 - 12 (2)(b)(III), (3)(a) introductory portion, (3)(c)(I), (3)(c)(III), (8)(e)(I), and
 - 13 (9); and **repeal** (2)(b)(V) as follows:".
 - 14 Page 10 of the printed bill, strike lines 6 through 15 and substitute:".
 - 15 Page 5 of the report, line 13, before "(2) (b) (III)" insert "**reporting -**
 - 16 **rules - definitions - repeal**.".
 - 17 Page 5 of the report, after line 18 insert:

1 "~~(V) This subsection (2) is repealed, effective September 1,~~
2 ~~2027.~~".

3 Page 6 of the report, strike lines 1 through 4.

4 Strike "ELEVEN" and substitute "TEN" on: **Page 3** of the report, line 16;
5 **Page 3** of the report, line 24; and **Page 4** of the report, line 13.

6 Page 6 of the report, after line 16 insert:

7 "Page 10 of the bill, after line 17 insert:

8 "**SECTION 7. Appropriation.** (1) For the 2023-24 state fiscal
9 year, \$337,878 General Fund is appropriated to the department of
10 agriculture. To implement this act, the department may use this
11 appropriation as follows:

12 (a) \$88,286 for use by the commissioner's office for personal
13 services, which amount is based on an assumption that the commissioner's
14 office will require an additional 1.0 FTE;

15 (b) \$44,411 for use by the commissioner's office for legal
16 services;

17 (c) \$205,181 for use by the agricultural markets division for the
18 community food access program, which amount is based on an
19 assumption that the department will require an additional 1.8 FTE.

20 (2) For the 2023-24 state fiscal year, \$44,411 is appropriated to the
21 department of law. This appropriation is from reappropriated funds
22 received from the department of agriculture under subsection (1)(b) of
23 this section. To implement this act, the department of law may use this
24 appropriation to provide legal services for the department of agriculture."

25 (3) For the 2023-24 state fiscal year, \$162,477 is appropriated to
26 the department of revenue for use by the taxation business group. This
27 appropriation is from the general fund. To implement this act, the division
28 may use this appropriation as follows:

29 (a) \$64,862 for personal services related to taxation services,
30 which amount is based on an assumption that the division will require an
31 additional 0.7 FTE;

32 (b) \$7,615 for operating expense related to taxation services; and

33 (c) \$90,000 tax administration IT system (gentax) support."

34 Renumber succeeding section accordingly."

35 Page 6 of the report, after line 20 insert:

- 1 "Page 1 of the bill, line 107, strike "AND".
- 2 Page 1 of the bill, line 109, strike "INCENTIVES." and substitute
- 3 "INCENTIVES, AND MAKING AN APPROPRIATION.".".
