- 4 "SECTION 5. In Colorado Revised Statutes, 25-20.5-801, amend 5 (9)(e) as follows:
 - **25-20.5-801.** Community crime victims grant program created cash fund repeal. (9) (e) The state treasurer shall transfer all unexpended and unencumbered money in the fund on September 1, 2024, AUGUST 31, 2023, to the general fund.
 - **SECTION 6.** In Colorado Revised Statutes, 25-20.5-801, **amend** (9)(e); and **add** (11) as follows:
 - **25-20.5-801.** Community crime victims grant program created cash fund repeal. (9) (e) The state treasurer shall transfer all unexpended and unencumbered money in the fund on September 1, 2024, AUGUST 31, 2028, to the general fund.
 - (11) ON SEPTEMBER 1, 2023, AND ON JULY 1 EACH YEAR THEREAFTER, THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS TO THE COMMUNITY CRIME VICTIMS GRANT PROGRAM CASH FUND CREATED IN SUBSECTION (9) OF THIS SECTION.
 - **SECTION 7. Effective date.** (1) Except as otherwise provided in this section, this act takes effect upon passage.
 - (2) Section 5 of this act takes effect only if Senate Bill 23-160 does not become law.
- 24 (3) Section 6 of this act takes effect only if Senate Bill 23-160 25 becomes law, in which case section 6 take effect upon the effective date 26 of this act or Senate Bill 23-160, whichever is later.".
