HB23-1112 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

12 5, 12, and 24; **Page 10**, lines 4 and 11; **Page 11**, lines 1, 8, and 16; and
13 **Page 12**, lines 1, 8, and 15.
- 14 Strike "FOR INCOME TAX YEARS COMMENCING ON OR AFTER" and
15 substitute "FOR THE INCOME TAX YEAR COMMENCING ON" on: **Page 6**, line
16 22; **Page 7**, lines 1, 8, 20, and 26; **Page 8**, lines 6 and 26; **Page 9**, lines 6,
17 13, and 25; **Page 10**, lines 5 and 12; **Page 11**, lines 2, 9, and 17; and **Page**
