Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB23-1269 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Public and Behavioral Health and Human Services Committee
- 2 Report, dated April 11, 2023, page 1, strike line 10 and substitute:
 - 3 "(b) THE STATE".
- 4 Page 1 of the report, line 12, strike "2023-24 AND 2024-25" and substitute
- 5 "2022-23 AND 2023-24".
- 6 Page 2 of the report, after line 17 insert:
 - 7 "Page 5 of the bill, strike line 22 and substitute "AGE, THE BHA SHALL
 - 8 CONSULT WITH A WORKING GROUP, INCLUDING MEMBERS FROM".
- 9 Page 5 of the bill, strike lines 26 and 27 and substitute "RELEVANT
- 10 STAKEHOLDERS, INCLUDING STAKEHOLDERS WHO REPRESENT INDIVIDUALS
- 11 WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES, TO HELP
- 12 DEVELOP THE PERFORMANCE MONITORING SYSTEM FRAMEWORK THAT
- 13 ADDRESSES THE MINIMUM PERFORMANCE STANDARDS FOR TREATMENT OF
- 14 CHILDREN AND YOUTH PURSUANT TO SUBSECTION (2) OF THIS SECTION.".

- 16 MUST CONSIDER MEASURES OF".
- 17 Page 6 of the bill, strike lines 4 through 17 and substitute "EXTENDED
- 18 STAY".
- 19 Page 6 of the bill, strike line 18 and substitute:

1 "(b) THE WORKING GROUP MAY,"."

2 Page 2 of the report, after line 19 insert:

10 FEDERAL PRIVACY LAWS".

11 Page 7 of the bill, line 17, strike "DE-IDENTIFIED".

12 Page 7 of the bill, line 18, before "ON" insert "THAT ARE CONSISTENT
13 WITH FEDERAL PRIVACY LAWS".

14 Page 2 of the report, after line 20 insert:

15 "Page 8 of the bill, line 1, strike "BEHAVIORAL" and substitute "WORKING
16 GROUP."."

17 Page 2 of the report, strike line 21 and substitute:

18 "Page 8 of the bill, strike lines 2 through 8 and substitute "THE BHA".

21 "**SECTION 7. Appropriation.** For the 2023-24 state fiscal year,
22 \$5,900,000 is appropriated to the department of human services for use

24 acuity treatment and services cash fund created in section 26-5-104
25 (7.5)(a), C.R.S. To implement this act, the division may use this
26 appropriation for high-acuity treatment and services. Any money
27 appropriated in this section not expended prior to July 1, 2024, is further
28 appropriated to the department for the 2024-25 state fiscal year for the

- 3 Page 2 of the report, after line 30 insert:
- 4 "Page 1 of the bill, line 102, strike "SYSTEM." and substitute "SYSTEM,
- 5 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."**".
