After consideration on the merits, the Committee recommends the following:

SB23-051 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend printed bill, page 6, line 23, strike "(5), (10)," and substitute  
2 "(10)".
- 3 Page 7, strike lines 21 through 23.
- 4 Page 9, line 5, strike "RECOGNIZED STATE APPRENTICESHIP AGENCY" and  
5 substitute "STATE APPRENTICESHIP AGENCY THAT IS RECOGNIZED BY THE  
6 UNITED STATES DEPARTMENT OF LABOR'S OFFICE OF APPRENTICESHIP".
- 7 Page 10, line 19, strike "AND".
- 8 Page 10, line 23, strike "SYSTEM." and substitute "SYSTEM; AND".
- 9 Page 11, strike lines 9 through 11 and substitute:  
10 "(k) Monitor and evaluate apprenticeship programs' performance  
11 and compliance with federal and state standards. ~~and report to the SAC  
12 and the IAC on the outcome of quality assurance assessments;~~".
- 13 Page 16, strike line 23 and substitute "(1), (2), (4) introductory portion,  
14 and (4)(a) as follows:".
- 15 Page 17, after line 16 insert:  
16 "(a) Workers in the occupation perform construction,  
17 reconstruction, renovation, alteration, demolition, painting, repair, or  
18 maintenance work for roads, highways, buildings, structures, industrial  
19 facilities, OR ENERGY PRODUCTION, ENERGY TRANSMISSION, OR ENERGY  
20 DISTRIBUTION, or improvements of any type; or".

1 Page 27, after line 18 insert:

3 "SECTION 26. In Colorado Revised Statutes, 24-75-112, amend  
4 (1)(d)(V) as follows:

5 **24-75-112. Annual general appropriation act - headnote**  
6 **definitions - general provisions - footnotes.** (1) As used in the annual  
7 general appropriation act, the following definitions and general provisions  
8 shall apply for the headnote terms preceding and specifying the purpose  
9 of certain line items of appropriation:

10 (d) (V) The number of FTE specified in a particular item of  
11 appropriation is the number utilized to calculate the amount appropriated  
12 and necessary to fund any combination of part-time positions or full-time  
13 positions equal to such number for the fiscal year to which the annual  
14 general appropriation act pertains in accordance with the definition  
15 contained in subsections (1)(d)(II) and (1)(d)(III) of this section and is not  
16 a limitation on the number of FTE that may be employed. No department  
17 shall make a material change in the number of FTE specified in a  
18 particular item of appropriation prior to notifying the joint budget  
19 committee in writing of such change. This subsection (1)(d)(V) does not  
20 apply to ~~department of personnel and administration~~ state trainee  
21 positions.".
