3 (G) A NOTICE THAT AN UNPAID PENALTY WILL BE REPORTED TO 4 THE DEPARTMENT AND MAY RESULT IN THE DEPARTMENT PROHIBITING THE 5 RENEWAL OF THE REGISTRATION OF THE MOTOR VEHICLE OR PROHIBITING 6 THE TRANSFER OF TITLE OF THE MOTOR VEHICLE AND THAT THE 7 DEPARTMENT MAY IMPOSE A TWENTY-FIVE-DOLLAR FEE TO COVER ITS 8 ADMINISTRATIVE COSTS.".

- 16 19 and 24; Page 8, lines 2 and 20; Page 9, lines 2, 14, and 17; Page 11,
- 17 line 15; **Page 13**, line 8; **Page 17**, lines 4 and 21.
- 18 Strike "CITY" and substitute "MUNICIPALITY" on **Page 8**, line 9; **Page 10**,
- 19 line 24; Page 11, line 1; Page 12, line 25; Page 14, line 25.
