<u>HB24-1031</u> be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

Amend the Health & Human Services Committee Report, dated January
 30, 2024, page 1 of the committee report, strike lines 1 through 5 and
 substitute:

4 "Amend printed bill, page 2, line 8, after "PROFICIENCY." insert 5 ""LANGUAGE ACCESS" INCLUDES THE PROVISION OF EFFECTIVE 6 COMMUNICATION SUPPORTS, SERVICES, AND ACCOMMODATIONS AS 7 DESCRIBED IN THE FEDERAL "AMERICANS WITH DISABILITIES ACT OF 8 1990", 42 U.S.C. SEC. 12101 ET SEQ., AS AMENDED, AND ITS RELATED 9 AMENDMENTS AND IMPLEMENTING REGULATIONS.".

Page 1 of the committee report, strike lines 8 through 20 and substitute: 12 "Page 4 of the bill, line 3, strike "(6) REASONABLE" and substitute: 13 14 "(6) IN ADOPTING A TREATMENT PLAN, THE COURT SHALL CONSIDER 15 SERVICES AND PROGRAMS THAT PROVIDE THE PARENT AND CHILD WITH 16 LANGUAGE ACCESS AND IDENTIFY THE MANNER IN WHICH THE COUNTY 17 DEPARTMENT ENSURES THE PROVISION OF LANGUAGE ACCESS CONSISTENT 18 WITH THE REQUIREMENTS OF THE FEDERAL "AMERICANS WITH 19 DISABILITIES ACT OF 1990", 42 U.S.C. SEC. 12101 ET SEQ., AS AMENDED, 20 AND ITS RELATED AMENDMENTS AND IMPLEMENTING REGULATIONS, AND 21 TITLE IV OF THE FEDERAL "CIVIL RIGHTS ACT OF 1964", 42 U.S.C. SEC. 22 2000d et seq., as amended, and its related amendments and 23 IMPLEMENTING REGULATIONS.".

8 division may use this appropriation as follows:

9 (a) \$67,753 for general courts administration, which amount is 10 based on an assumption that the division will require an additional 0.8 11 FTE; and
