After consideration on the merits, the Committee recommends the following:

HB24-1031 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, lines 6 and 7, strike "THE PROVISION OF  
2 MEANINGFUL ACCESS TO SERVICES" and substitute "SERVICES PROVIDED  
3 BY A COURT, THE STATE DEPARTMENT, A COUNTY DEPARTMENT OF HUMAN  
4 OR SOCIAL SERVICES, A CITY AND COUNTY, OR A PRIVATE-ENTITY  
5 CONTRACTOR".
- 6 Page 3, lines 17 and 18, strike "THE PERSON HAS LIMITED ENGLISH  
7 PROFICIENCY AND".
- 8 Page 4, line 12, strike "JULY" and substitute "SEPTEMBER".
- 9 Page 4, strike lines 19 and 20 and substitute "BE SERVED BY A COUNTY  
10 DEPARTMENT OF HUMAN OR SOCIAL SERVICES;"
- 11 Page 4, lines 26 and 27, strike "THE DIVISION OF CHILD WELFARE IN THE  
12 STATE DEPARTMENT" and substitute "A COUNTY DEPARTMENT OF HUMAN  
13 OR SOCIAL SERVICES".
- 14 Page 5, strike lines 2 and 3 and substitute "ARE SERVED BY A COUNTY  
15 DEPARTMENT OF HUMAN OR SOCIAL SERVICES;"
- 16 Page 5, lines 5 and 6, strike "THE DIVISION OF CHILD WELFARE IN THE  
17 STATE DEPARTMENT," and substitute "A COUNTY DEPARTMENT OF HUMAN  
18 OR SOCIAL SERVICES,"
- 19 Page 5, lines 16 and 17, strike "THE DIVISION OF CHILD WELFARE" and  
20 substitute "A COUNTY DEPARTMENT OF HUMAN OR SOCIAL SERVICES".

1 Page 6, line 4, strike "PURSUANT TO THIS SECTION" and substitute "IN THE  
2 COURSE OF PROGRAMS, ACTIVITIES, OR SERVICES PROVIDED BY THE  
3 COUNTY DEPARTMENTS OF HUMAN OR SOCIAL SERVICES".

4 Strike "PEOPLE" and substitute "PERSONS" on: **Page 4**, lines 21 and 25;  
5 and **Page 5**, line 16.
