- 2 PARTICIPATE IN A PRECINCT CAUCUS OR A PARTY ASSEMBLY WITH THE USE
- 3 OF A VIDEO CONFERENCING PLATFORM, OR AN ALTERNATIVE TO A VIDEO
- 4 CONFERENCING PLATFORM AS PROVIDED IN SUBSECTION (2)(c), NOT MORE
- 5 THAN THIRTY DAYS IN ADVANCE OF THE PRECINCT CAUCUS OR PARTY
- 6 ASSEMBLY.".
- 7 Page 3, line 27, after "TO" add "MAKE A REASONABLE EFFORT TO".
- 8 Page 4, after line 4 add:
- 9 "(4) ANY ACTION TAKEN PURSUANT TO THIS SECTION DOES NOT
- 10 LIMIT OR PRECLUDE A PERSON FROM SECURING OR RECOVERING ANY
- 11 OTHER AVAILABLE REMEDY INCLUDING ANY REMEDY PROVIDED BY THE
- 12 FEDERAL "AMERICANS WITH DISABILITIES ACT OF 1990", 42 U.S.C. SEC.
- 13 12101 ET SEQ., AS AMENDED, AND THE COLORADO ANTI-DISCRIMINATION
- 14 ACT, PARTS 3 THROUGH 8 OF ARTICLE 34 OF TITLE 24.".
