After consideration on the merits, the Committee recommends the following:

HB24-1080 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 2, strike lines 2 through 14.

2 Renumber succeeding sections accordingly.

3 Page 3, strike lines 3 through 16 and substitute:

4 (1) "YOUTH ATHLETIC ACTIVITY" MEANS AN ORGANIZED
5 ATHLETIC ACTIVITY IN WHICH THE MAJORITY OF THE PARTICIPANTS ARE
6 UNDER EIGHTEEN YEARS OF AGE AND ARE ENGAGING IN AN ORGANIZED
7 ATHLETIC GAME, COMPETITION, OR TRAINING PROGRAM. "YOUTH
8 ATHLETIC ACTIVITY" DOES NOT INCLUDE AN ATHLETIC ACTIVITY THAT IS
9 INCIDENTAL TO A NONATHLETIC PROGRAM OR A LESSON.

10 (2) "YOUTH SPORTS ORGANIZATION" HAS THE SAME MEANING AS
11 IN SECTION 26.5-5-304.5 (4)."

12 Page 3, strike lines 18 through 24 and substitute:

13 **"aid guidelines required.** (1) (a) EXCEPT AS PROVIDED FOR IN
14 SUBSECTION (1)(b) OF THIS SECTION, EACH YOUTH SPORTS ORGANIZATION
15 SHALL ENSURE THAT AT LEAST ONE ADULT WHO POSSESSES A CURRENT
16 FIRST AID AND CPR/AED CERTIFICATION IS PRESENT AT EACH YOUTH
17 ATHLETIC ACTIVITY.

18 (b) IF A YOUTH SPORTS ORGANIZATION CONDUCTS A YOUTH
19 ATHLETIC ACTIVITY AT A FACILITY THAT HAS STAFF ON SITE DURING THE
20 YOUTH ATHLETIC ACTIVITY WHO ARE FIRST AID AND CPR/AED CERTIFIED
21 SUBSECTION (1)(a) OF THIS SECTION DOES NOT APPLY.

22 (c) A YOUTH ATHLETIC ACTIVITY THAT IS CONDUCTED ENTIRELY
23 BY VOLUNTEERS FOR TRAINING PURPOSES ONLY ARE EXEMPT FROM THIS
24 SECTION, BUT THE VOLUNTEERS ARE STRONGLY ENCOURAGED TO POSSESS
25 A CURRENT FIRST AID AND CPR/AED CERTIFICATION."

- 1 Page 4, line 5, strike "RESUSCITATION." and substitute
2 "RESUSCITATION/AUTOMATIC EXTERNAL DEFIBRILLATOR TRAINING."
- 3 Page 4, line 6, strike "PRIVATE CLUB OR PUBLIC RECREATION FACILITY"
4 and substitute "YOUTH SPORTS ORGANIZATION".
- 5 Page 5, line 9, after the period insert "IF AN EMPLOYEE OR VOLUNTEER
6 HAS LIVED OUTSIDE OF THE UNITED STATES FOR MORE THAN ONE
7 HUNDRED EIGHTY DAYS IN PAST TEN YEARS OR ONE HUNDRED EIGHTY
8 DAYS SINCE THE EMPLOYEE'S OR VOLUNTEER'S LAST BACKGROUND CHECK
9 WAS CONDUCTED, THE EMPLOYEE OR VOLUNTEER SHALL ALSO OBTAIN AN
10 INTERNATIONAL CRIMINAL HISTORY RECORD CHECK THAT AT A MINIMUM
11 DISCLOSES SEXUAL OFFENDERS AND FELONY CONVICTIONS."
- 12 Page 6, strike line 7 and substitute "THE TEAM."
- 13 Page 6, line 8, strike "IN THE YOUTH SPORTS ORGANIZATION."
- 14 Page 6, strike lines 19 through 24 and substitute:
- 15 "(c) (I) "YOUTH SPORTS ORGANIZATION" MEANS A PUBLIC
16 ORGANIZATION OR PRIVATE FOR-PROFIT OR NOT-FOR-PROFIT
17 ORGANIZATION THAT, AS PART OF ITS CORE FUNCTION, PROVIDES PERSONS
18 WHO ARE UNDER EIGHTEEN YEARS OF AGE THE OPPORTUNITY TO
19 PARTICIPATE IN SCHEDULED COMPETITIVE OR RECREATIONAL SPORTING
20 ACTIVITIES, WHETHER INDIVIDUALLY OR AS A TEAM."
- 21 Page 7, line 22, strike "TIME WITHIN" and substitute "TIME."
- 22 Page 7, strike line 23.
- 23 Page 8, strike lines 9 through 13 and substitute:
- 24 "(b) THE INDIVIDUAL, AT THE TIME OF HIRING, WAS NOT ELIGIBLE
25 TO BE HIRED PURSUANT TO SECTION 26.5-5-304.5 (2)(b); AND".
- 26 Page 8, strike lines 21 through 24.
