Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB24-1115 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend the Health and Human Services Committee Report, dated March
- 2 12, 2024, page 1, strike line 8 and substitute ""SUBSECTIONS (4)(c) AND
- 3 (4)(d)".
  
- 4 Page 1, strike line 14 and substitute:
- 5 ""(d) IF A PATIENT REQUESTS A METHOD OF ACCESS THAT THE
- 6 PHARMACY HAS NOT YET BEEN ASKED TO PROVIDE TO ANY OTHER
- 7 PATIENT, THE PHARMACY MUST NOT TAKE MORE THAN TWENTY-EIGHT
- 8 DAYS TO COMPLY WITH SUBSECTION (4)(b) OF THIS SECTION. THE
- 9 PHARMACY SHALL MAKE REASONABLE EFFORTS TO ENSURE PATIENT
- 10 SAFETY AND ACCESS DURING THE TIME IT TAKES TO PROVIDE THE
- 11 REQUESTED METHOD OF ACCESSIBILITY.
- 12 (e) PHARMACIES SHALL MAKE GOOD FAITH, SUSTAINED,
- 13 PERIODIC,".
  
- 14 Page 1, line 19, strike "(e)" and substitute "(f)".
  
- 15 Page 2, line 21, strike "(6)" and substitute "(5)".
  
- 16 Page 2, strike lines 23 through 26.
  
- 17 Renumber succeeding subsections accordingly.
  
- 18 Page 2, strike lines 36 and 37 and substitute "SECTION."
  
- 19 Page 3, strike line 11 and substitute: "GRANT PROGRAM. ANY MONEY
- 20 APPROPRIATED PURSUANT TO THIS SUBSECTION (7) THAT IS NOT EXPENDED
- 21 OR ENCUMBERED AT THE END OF THE 2024-25 STATE FISCAL YEAR

1 REMAINS AVAILABLE FOR EXPENDITURE BY THE DEPARTMENT FOR THE  
2 PURPOSES OF THIS SECTION IN THE NEXT STATE FISCAL YEAR WITHOUT  
3 FURTHER APPROPRIATION."

4 Page 3, after line 12 insert:

5           **"SECTION 3. Appropriation.** (1) For the 2024-25 state fiscal  
6 year, \$72,886 is appropriated to the department of public health and  
7 environment for use by the prevention services division. This  
8 appropriation is from the general fund and is based on an assumption that  
9 the division will require an additional 0.1 FTE. To implement this act, the  
10 division may use this appropriation for the prescription accessibility grant  
11 program related to chronic disease prevention programs.

12           (2) For the 2024-25 state fiscal year, \$3,650 is appropriated to the  
13 department of corrections for use by the institutions division. This  
14 appropriation is from the general fund. To implement this act, the division  
15 may use this appropriation for operating expenses related to the medical  
16 services subprogram."

17 Page 3, line 13, strike "**SECTION 3.**" and substitute "**SECTION 4.**"

18 Page 3, after line 21 insert:

19 "Page 1, line 101, strike "**INFORMATION.**" and substitute "**INFORMATION,**  
20 **AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
