<u>HB24-1123</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

1 Amend printed bill, page 2, strike lines 2 through 22.

2 Strike page 3.

3 Page 4, strike lines 1 through 6 and substitute:

4 "SECTION 1. In Colorado Revised Statutes, 24-33.5-1810, 5 amend (3)(h) and (3)(i); and add (3)(j) as follows:

6 24-33.5-1810. School security disbursement program - created
7 - rules - definitions - repeal. (3) An eligible entity that receives a
disbursement from the disbursement program may use the disbursed
9 money only for the following purposes:

(h) Implementing a school resource officer program; and

(i) To implement a co-responder program; AND

(j) TO PURCHASE, INSTALL, AND OPERATE FIREARM DETECTION
SOFTWARE TO DETECT, AND ALERT LOCAL EDUCATION PROVIDER
PERSONNEL AND FIRST RESPONDERS ABOUT, THE PRESENCE OF VISIBLE,
UNHOLSTERED FIREARMS ON SCHOOL PROPERTY. THE SOFTWARE MUST
MEET THE REQUIREMENTS SET FORTH IN SECTION 24-33.5-1812.

SECTION 2. In Colorado Revised Statutes, add 24-33.5-1812 as
follows:

19 24-33.5-1812. School security disbursement program - firearm
20 detection software. (1) PURSUANT TO SECTION 24-33.5-1810 (3)(j), AN
21 ELIGIBLE ENTITY MAY USE A DISBURSEMENT FROM THE SCHOOL SECURITY
22 DISBURSEMENT PROGRAM TO PURCHASE, INSTALL, AND OPERATE FIREARM
23 DETECTION SOFTWARE.".

8 MONEY FOR FIREARM DETECTION SOFTWARE SHALL INCLUDE THE
9 FOLLOWING INFORMATION IN ITS REPORT TO THE DEPARTMENT REQUIRED
10 PURSUANT TO SECTION 24-33.5-1810 (6)(a):".

- 16 SHALL INCLUDE A SUMMARY OF THE INFORMATION REPORTED TO IT BY
- 17 ELIGIBLE ENTITIES PURSUANT TO SUBSECTION (2) OF THIS SECTION.".
