<u>HB24-1152</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

Amend printed bill, page 3, line 5, strike "Affordable Housing" and
 substitute "Strategic Growth".

Page 6, strike lines 1 through 5 and substitute "BETTER USE OF EXISTING
INFRASTRUCTURE.".

5 Page 10, strike lines 7 through 27.

6 Page 11, strike lines 1 through 21 and substitute:

REGARDING A DEVELOPMENT APPLICATION INVOLVING A PROPERTY THAT

(I) THE STATE HISTORIC PRESERVATION OFFICE WITHIN HISTORY
