(VII) FOR PROPERTY, LANDS, AND WATERS OWNED OR MANAGED,
IN WHOLE OR IN PART, BY THE PARKS AND WILDLIFE COMMISSION OR THE
DIVISION OF PARKS AND WILDLIFE.".

8 Page 4, line 15, strike "OR".

9 Page 4, strike lines 16 and 17 and substitute:

WORKER SPECIFICATIONS; CONTAINER STORAGE AND DISPOSAL; REQUIRED

INTERVALS BETWEEN APPLICATION AND HARVEST OF FOOD OR FEED CROPS;
 ROTATIONAL CROP RESTRICTIONS; WARNINGS AGAINST USE ON CERTAIN
 CROPS, ANIMALS, OR OBJECTS; ANY LABEL-SPECIFIED WARNINGS AND
 PRECAUTIONARY STATEMENTS OR STATEMENTS OF PRACTICAL
 TREATMENT; OR LICENSURE, TRAINING, OR CERTIFICATION REQUIREMENTS,
 INCLUDING ANY INSURANCE AND RECORD-KEEPING REQUIREMENTS.".

Page 4, strike line 21 and substitute "OR RULE OR REGULATION WITH
RESPECT TO PESTICIDES OR TO TAKE ANY ACTION OTHERWISE PROHIBITED
BY THIS SECTION IN ORDER TO COMPLY WITH ANY SPECIFIC FEDERAL OR
STATE REQUIREMENT OR AVOID A FINE OR OTHER PENALTY UNDER
FEDERAL OR STATE LAW.".
