After consideration on the merits, the Committee recommends the following:

HB24-1178 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 3, line 27, after "CONVEYANCE" insert "OR
2 APPURTENANT FACILITIES" and strike "SUPPLIES" and substitute "SUPPLY".

3 Page 4, line 9, strike "OR".

4 Page 4, line 10, strike "MARIJUANA." and substitute "MARIJUANA; OR
5 (VII) FOR PROPERTY, LANDS, AND WATERS OWNED OR MANAGED,
6 IN WHOLE OR IN PART, BY THE PARKS AND WILDLIFE COMMISSION OR THE
7 DIVISION OF PARKS AND WILDLIFE.".

8 Page 4, line 15, strike "OR".

9 Page 4, strike lines 16 and 17 and substitute:

10 "(II) USED BY A COMMERCIAL APPLICATOR, QUALIFIED
11 SUPERVISOR, CERTIFIED OPERATOR, OR TECHNICIAN WORKING IN
12 STRUCTURAL OR PUBLIC HEALTH PEST CONTROL TO ASSIST IN COMPLIANCE
13 WITH FEDERAL LAW, PART 10 OF ARTICLE 12 OF TITLE 38, OR SECTION
14 38-12-505;

15 (III) INCONSISTENT WITH THE "COLORADO NOXIOUS WEED ACT",
16 ARTICLE 5.5 OF TITLE 35; OR

17 (IV) RELATED TO: THE LABELING OR REGISTRATION
18 REQUIREMENTS FOR PESTICIDES; DIRECTIONS FOR USE; CLASSIFICATION OF
19 PESTICIDES AS GENERAL OR RESTRICTED USE; MIXING AND LOADING;
20 LABEL-SPECIFIED SITES OF APPLICATION; TARGET PESTS; DOSAGE RATE;
21 METHOD OF APPLICATION; APPLICATION EQUIPMENT; FREQUENCY AND
22 TIMING OF APPLICATIONS; APPLICATION RATE; REENTRY INTERVALS;
23 WORKER SPECIFICATIONS; CONTAINER STORAGE AND DISPOSAL; REQUIRED

1 INTERVALS BETWEEN APPLICATION AND HARVEST OF FOOD OR FEED CROPS;
2 ROTATIONAL CROP RESTRICTIONS; WARNINGS AGAINST USE ON CERTAIN
3 CROPS, ANIMALS, OR OBJECTS; ANY LABEL-SPECIFIED WARNINGS AND
4 PRECAUTIONARY STATEMENTS OR STATEMENTS OF PRACTICAL
5 TREATMENT; OR LICENSURE, TRAINING, OR CERTIFICATION REQUIREMENTS,
6 INCLUDING ANY INSURANCE AND RECORD-KEEPING REQUIREMENTS."

7 Page 4, line 20, strike "A" and substitute "ANY".

8 Page 4, strike line 21 and substitute "OR RULE OR REGULATION WITH
9 RESPECT TO PESTICIDES OR TO TAKE ANY ACTION OTHERWISE PROHIBITED
10 BY THIS SECTION IN ORDER TO COMPLY WITH ANY SPECIFIC FEDERAL OR
11 STATE REQUIREMENT OR AVOID A FINE OR OTHER PENALTY UNDER
12 FEDERAL OR STATE LAW."
