After consideration on the merits, the Committee recommends the following:

HB24-1245 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, strike lines 5 through 8 and substitute
2 **"responsibilities - gifts, grants, or donations. (6) (a) FOR"**.

3 Page 2, lines 13 and 14, strike "MONEY. ADDITIONALLY, FOR PROJECTS
4 THAT" and substitute "MONEY, WHERE PROJECTS".

5 Page 2, strike lines 18 through 22.

6 Page 3, strike lines 1 through 24 and substitute:

7 "(b) GRANTEES OF FUNDING ADMINISTERED OR DISTRIBUTED BY
8 THE BROADBAND OFFICE SHALL PROVIDE TO THE BROADBAND OFFICE
9 BIENNIAL REPORTS THAT CONTAIN INFORMATION ON THE GRANTEE'S
10 WORKFORCE IN ACCORDANCE WITH THIS SUBSECTION (6)(b). THE
11 BROADBAND OFFICE SHALL MAKE THE REPORTS PUBLICLY AVAILABLE ON
12 ITS WEBSITE. THE REPORTS MUST INCLUDE:

13 (I) JOB TITLES AND SIZE OF A GRANTEE'S WORKFORCE, INCLUDING
14 THE NUMBER OF FULL-TIME EQUIVALENT POSITIONS THAT ARE REQUIRED
15 TO CARRY OUT THE FUNDED WORK OVER THE COURSE OF THE PROJECT;

16 (II) IF THE WORKFORCE IS DIRECTLY EMPLOYED BY THE GRANTEE
17 OR THE INTERNET SERVICE PROVIDER OR IF WORK WILL BE PERFORMED BY
18 A SUBCONTRACTED WORKFORCE;

19 (III) IDENTIFICATION OF ANY ENTITIES THAT THE GRANTEE
20 SUBCONTRACTS WITH IN CARRYING OUT THE FUNDED WORK AND
21 IDENTIFICATION OF THE ENTITY THAT IS FUNCTIONING AS THE LEGAL
22 EMPLOYER OF THE WORKERS IN EACH JOB TITLE ASSOCIATED WITH THE
23 PROJECT; AND

24 (IV) A DESCRIPTION OF WHETHER THE GRANTEE'S WORKFORCE IS

1 SUBJECT TO COMPLIANCE WITH THE STATE'S LAWS CONCERNING
2 OVERTIME, BREAKS, PAID SICK TIME, MISCLASSIFICATION, AND PAID
3 FAMILY AND MEDICAL LEAVE AND A DESCRIPTION OF ANY LEGAL ACTION
4 THE GRANTEE HAS BEEN INVOLVED IN DURING THE REPORTING PERIOD
5 CONCERNING ANY OF THESE LAWS."
