Committee on Judiciary.

After consideration on the merits, the Committee recommends the following:

HB24-1292 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend page 13, line 8, strike "SUBSECTION (2)" and substitute  
2 "SUBSECTIONS (2) AND (3)".

3 Page 13, strike lines 15 through 18 and substitute:

4 "(a) A PERSON WHO IS AN ACTIVE MEMBER OF THE UNITED STATES  
5 ARMED FORCES WHILE ON DUTY AND SERVING IN CONFORMANCE WITH THE  
6 POLICIES OF THE UNITED STATES ARMED FORCES;"

7 Page 14, line 18, strike "OFFICER;" and substitute "OFFICER, AS DESCRIBED  
8 IN SECTION 16-2.5-101, WHILE ON DUTY AND SERVING IN CONFORMANCE  
9 WITH THE POLICIES OF THE EMPLOYING AGENCY, AS SET FORTH IN  
10 SECTIONS 16-2.5-101 AND 16-2.5-135;"

11 Page 14, after line 20 insert:

12 "(3) AN ASSAULT WEAPON SHALL NOT BE SOLD OR TRANSFERRED  
13 BY AN INDIVIDUAL ON OR AFTER JULY 1, 2024, TO ANYONE WITHIN THE  
14 STATE, EXCEPT TO:

15 (a) AN HEIR BY BEQUEST OR INTESTATE SUCCESSION; OR

16 (b) A LICENSED GUN OR FIREARMS DEALER, WHO SHALL RENDER  
17 THE WEAPON INOPERABLE WITHIN NINETY DAYS OF THE TRANSFER."

18 Renumber succeeding subsection accordingly.

19 Page 14, strike lines 23 through 27 and substitute "WEAPON ON OR AFTER  
20 JULY 1, 2024, IS GUILTY OF A PETTY OFFENSE, AS PROVIDED IN SECTION  
21 18-1.3-503."

1 Page 16, line 2, strike "SHALL BE ASSESSED A".

2 Page 16, strike lines 3 through 7 and substitute "IS GUILTY OF A PETTY  
3 OFFENSE, AS PROVIDED IN SECTION 18-1.3-503."

4 Page 16, after line 7 insert:

5 **"18-12-605. Interstate transportation of assault weapons.** THIS  
6 PART 6 DOES NOT APPLY TO THE TRANSPORTATION OF ASSAULT WEAPONS  
7 THROUGH THE STATE BY A PERSON WHO IS NOT OTHERWISE PROHIBITED BY  
8 STATE OR FEDERAL LAW FROM TRANSPORTING, SHIPPING, OR RECEIVING A  
9 FIREARM. A PERSON IS ENTITLED TO TRANSPORT AN ASSAULT WEAPON FOR  
10 ANY LAWFUL PURPOSE FROM ANY PLACE WHERE THE PERSON MAY  
11 LAWFULLY POSSESS AND CARRY THE ASSAULT WEAPON TO ANY OTHER  
12 PLACE WHERE THE PERSON MAY LAWFULLY POSSESS AND CARRY THE  
13 ASSAULT WEAPON, PROVIDED THAT THE ASSAULT WEAPON IS  
14 TRANSPORTED IN ACCORDANCE WITH THE FEDERAL REQUIREMENTS SET  
15 FORTH IN 18 U.S.C. SEC 926(a)."
