HB24-1344 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:
Amend printed bill, page 4, line 18, strike "(2)(a)(I) introductory portion and".
Page 4, strike lines 20 through 23 and substitute " <b>of article.</b> (4) No major political party shall be represented on the board by".
Page 4, line 25, strike "2037." and substitute "2032.".
Page 5, line 3, strike "(2)(a)(I) introductory portion and".
Page 5, lines 6 and 7, strike "and with the confirmation of the senate," and substitute "and with the confirmation of the senate,".
Page 10, line 13, strike "(2)" and substitute "(2); and <b>add</b> (1)(s)".
Page 10, after line 24 insert:
"(s) Failing to display plumbing contractor and master plumber registration information, as specified in section 12-155-125.".
Page 12, line 27, after "(2)" insert "and (4)".
Page 13, after line 14 insert:

"(4) Persons who are engaged in the business of INSTALLING,

REMOVING, inspecting, testing, and repairing backflow prevention devices

shall be ARE NOT exempt from licensure under this article 155, except

- when the persons engage in the installation and removal of the devices
- 2 ARE INSTALLING OR TESTING A STAND-ALONE FIRE SUPPRESSION
- 3 SPRINKLER SYSTEM.".

- 18 **12-20-202.** Licenses, certifications, and registrations renewal reinstatement fees occupational credential portability program
- 20 temporary authority for military spouses exceptions for military
- personnel rules consideration of criminal convictions or driver's history - executive director authority - definitions - repeal.
- 23 (1) **Renewal.** (f) (I) NOTWITHSTANDING ANY PROVISION OF THE LAW TO
- 24 THE CONTRARY, THE DIRECTOR SHALL CHANGE THE VALIDITY OF LICENSES
- 25 AND REGISTRATIONS ISSUED OR RENEWED BY THE STATE PLUMBING
