HB24-1378 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Amend reengrossed bill, page 2, line 16, strike the first "TICKET" and
- 2 substitute "TICKET, AS APPLICABLE,".
- 3 Page 3, line 4, strike "OPERATOR" and substitute "OPERATOR, AS
- 4 APPLICABLE,".
- 5 Page 3, line 6, strike "OPERATOR" and substitute "OPERATOR, AS
- 6 APPLICABLE,".
- 7 Page 3, line 7, before "conform" insert "REASONABLY".
- 8 Page 3, strike lines 20 through 27 and substitute:
- 9 "(B) BY OR ON BEHALF OF A CHARITABLE ORGANIZATION, AS
- 10 DEFINED IN SECTION 6-16-103 (1), FOR A CHARITABLE PURPOSE, AS
- DEFINED IN SECTION 6-16-103 (2), WHERE ALL PROCEEDS FROM THE
- 12 TICKET SALE ARE PROVIDED TO THE CHARITABLE ORGANIZATION.".
- Page 4, strike line 1.
- 14 Page 5, line 19, after "(e)" insert "(I)".
- Page 5, line 23, strike "THEREAFTER;" and substitute "THEREAFTER.
- 16 (II) A PERSON IS NOT REQUIRED TO INCLUDE THE AMOUNT OF ANY
- 17 SALES TAX REQUIRED TO PURCHASE A TICKET WHEN DISCLOSING THE
- 18 TOTAL COST OF A TICKET TO A PURCHASER IN ACCORDANCE WITH
- 19 SUBSECTION (1)(e)(I) OF THIS SECTION IF THE PERSON DISCLOSES THE
- 20 AMOUNT OF ANY SALES TAX TO THE PURCHASER PRIOR TO COMPLETION OF

- 1 THE TRANSACTION.".
- 2 Page 6, strike lines 8 through 13 and substitute:
- "(i) Increases the total price of a ticket after the first time a price is displayed to the purchaser; except that the person:
- 6 (I) SHALL ADD ANY APPLICABLE SALES TAX TO THE TOTAL PRICE 7 OF A TICKET PRIOR TO THE COMPLETION OF THE TRANSACTION BY THE 8 PURCHASER;
- 9 (II) MAY ADD FEES FOR THE DELIVERY OF NONELECTRONIC 10 TICKETS BASED ON DELIVERY TO THE PURCHASER'S ADDRESS OR THE 11 DELIVERY METHOD SELECTED BY THE PURCHASER IF THE PERSON 12 DISCLOSES THE AMOUNT OF EACH DELIVERY FEE PRIOR TO ACCEPTING 13 PAYMENT; AND
- 14 (III) MAY INCREASE THE TOTAL PRICE OF A TICKET IF THE 15 PURCHASER'S TRANSACTION PERIOD HAS TIMED OUT AND THE PURCHASER 16 HAS NOT YET PURCHASED THE TICKET.".
