SB24-034 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, before line 18 insert:

2 "(1) "LOCAL EDUCATION PROVIDER" MEANS A SCHOOL DISTRICT,
3 A CHARTER SCHOOL AUTHORIZED BY A SCHOOL DISTRICT PURSUANT TO
4 PART 1 OF ARTICLE 30.5 OF TITLE 22, A CHARTER SCHOOL AUTHORIZED BY
5 THE STATE CHARTER SCHOOL INSTITUTE PURSUANT TO PART 5 OF ARTICLE
6 30.5 OF TITLE 22, OR A BOARD OF COOPERATIVE SERVICES CREATED AND
7 OPERATING PURSUANT TO ARTICLE 5 OF TITLE 22."

8 Page 2, line 18, strike "(1)" and substitute "(1) (2)".

9 Page 2, line 19, strike "including charter schools and" and substitute
10 "~~including charter schools and~~ THROUGH".

11 Page 3, line 1, strike "school district, or" and substitute "~~school district,~~
12 ~~or~~ LOCAL EDUCATION PROVIDER,".

13 Page 3, line 2, strike "school district," and substitute "~~school district~~
14 LOCAL EDUCATION PROVIDER,".

15 Page 3, line 3, strike "by IN PARTNERSHIP WITH school" and substitute "by
16 ~~school~~".

17 Page 3, line 4, strike "districts, in" and substitute "~~districts, in~~" and before
18 "BY" insert "IN PARTNERSHIP WITH LOCAL EDUCATION PROVIDERS,".

19 Page 3, line 7, strike "centers." and substitute "centers, TO PROVIDE
20 PRIMARY HEALTH-CARE SERVICES, BEHAVIORAL HEALTH-CARE SERVICES,

1 ORAL HEATH-CARE SERVICES, OR PREVENTIVE HEALTH-CARE SERVICES TO
2 STUDENTS AND YOUTH WITHIN A SCHOOL OR SCHOOLS OF A LOCAL
3 EDUCATION PROVIDER REGARDLESS OF ABILITY TO PAY, INSURANCE
4 COVERAGE, OR IMMIGRATION STATUS."

5 Page 3, line 11, strike "OR" and substitute "AND".

6 Page 4, line 14, after "SERVICES" insert "BY A PROVIDER LOCATED IN THIS
7 STATE".
