Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB24-047 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 1 Strike the Finance Committee Report, dated February 27, 2024.
- 2 Amend printed bill, page 11, strike lines 18 through 27.
- 3 Page 12, strike lines 1 through 20.
- 4 Renumber succeeding sections accordingly.
- 5 Page 19, strike lines 8 through 27.
- 6 Strike pages 20 and 21.
- 7 Page 22, strike lines 1 through 10.
- 8 Renumber succeeding sections accordingly.
- 9 Page 24, strike lines 11 through 13 and substitute "OF TITLE 26; THE
- 10 COLORADO DEPARTMENT OF EDUCATION; OTHER DATA".
- 11 Page 25, strike lines 12 through 27.
- 12 Strike pages 26 and 27.
- 13 Page 28, strike lines 1 through 5.
- 14 Renumber succeeding section accordingly.
- 15 Page 28, before line 6 insert:

1 **"SECTION 16. Appropriation.** (1) For the 2024-25 state fiscal
2 year, \$75,000 is appropriated to the department of health care policy and
3 financing for use by the executive director's office. This appropriation is
4 from the general fund. To implement this act, the office may use this
5 appropriation for general professional services and special projects.

6 (2) For the 2024-25 state fiscal year, the general assembly
7 anticipates that the department of health care policy and financing will
8 receive \$75,000 in federal funds to implement this act, which amount is
9 subject to the "(I)" notation as defined in the annual general appropriation
10 act for the same fiscal year. The appropriation in subsection (1) of this
11 section is based on the assumption that the department will receive this
12 amount of federal funds to be used for general professional services and
13 special projects.

14 (3) For the 2024-25 state fiscal year, \$250,000 is appropriated to
15 the department of higher education for use by the Colorado commission
16 on higher education and higher education special purpose programs. This
17 appropriation is from the general fund. To implement this act, the division
18 may use this appropriation for the center for substance use disorder,
19 prevention, treatment, and recovery support strategies at the university of
20 Colorado health sciences center."

21 Renumber succeeding section accordingly.

22 Page 1, line 101, strike "**DISORDERS.**" and substitute "**DISORDERS, AND,**
23 **IN CONNECTION THEREWITH, MAKING AN APPROPRIATION.**".
