SB24-047 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 5, strike lines 15 and 16 and substitute:
 - 2 "(2.5) "MEDICAL DIRECTOR" MEANS A MEDICAL DIRECTOR OR
 - 3 NURSE MEDICAL DIRECTOR OF A MEDICAL PRACTICE OR HOSPITAL IN THIS
 - 4 STATE WHO IS A "PRESCRIBER" AS DEFINED IN SECTION 12-30-111 (4)".

 - 13 OF THE MEDICAL PRACTICE OR HOSPITAL UNDER THE DIRECTOR'S
 - 14 SUPERVISION; AND"

- 17 Page 10, line 3, strike "(3)(o)(I)" and substitute "(3)(n)(I)".
