After consideration on the merits, the Committee recommends the following:

<u>SB24-171</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

1 Amend printed bill, page 2, after line 11 insert:

2 "(d) Given the North American wolverine's status as federally 3 threatened, the division of parks and wildlife will be requesting that the 4 United States fish and wildlife service adopt a final rule pursuant to 16 5 U.S.C. sec. 1539(j), which would designate the reintroduced North 6 American wolverine population in Colorado as a nonessential experimental population. Through the final rule, the United States fish 7 8 and wildlife service would devise management programs and special 9 regulations for the North American wolverine to help relieve landowner and permittee concerns that reintroduction of the North American 10 wolverine in Colorado may result in restrictions on the use of private, 11 12 tribal, or public land; ensure adequate management flexibility; and 13 minimize the impact of the reintroduction on land use activities, including 14 big game habitat management projects.".

15 Reletter succeeding paragraphs accordingly.

16 Page 3, after line 24 insert:

17 "(b) "LIVESTOCK" HAS THE MEANING SET FORTH IN SECTION18 33-2-105.8 (5).".

- 19 Reletter succeeding paragraph accordingly.
- Page 3, line 27, strike "SUBJECT TO SUBSECTION (3) OF THIS SECTION," and
 substitute "SUBJECT TO THE REQUIREMENTS OF THIS SECTION,".

22 Page 4, line 24, strike "IN THE EVENT THAT THE DIVISION DEVELOPS" and

23 substitute "THE DIVISION SHALL DEVELOP".

Page 5, strike lines 6 through 9 and substitute "WOLVERINE IN THE STATE
 OCCURS, THE DEPARTMENT SHALL:

3 (I) PREPARE A REPORT IN ACCORDANCE WITH SECTION 33-2-105.7
4 (2) AND DELIVER THE REPORT IN ACCORDANCE WITH SECTION 33-2-105.7
5 (3); AND

6 (II) DEVELOP A COMMUNICATIONS PLAN THAT OUTLINES THE 7 DIVISION'S PLANNED COMMUNICATIONS FOR PROPOSED RELEASES OF THE 8 NORTH AMERICAN WOLVERINE. THE COMMUNICATIONS PLAN MUST 9 INCLUDE A DESCRIPTION OF HOW THE DIVISION WILL COMMUNICATE WITH 10 STAKEHOLDERS AND BOARDS OF COUNTY COMMISSIONERS IN GENERAL 11 LOCATIONS OF PROPOSED RELEASES OF THE NORTH AMERICAN 12 WOLVERINE.".
