- <u>SB24-190</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:
- 1 Amend printed bill, page 17, after line 19 insert:
- 2 "(11) **Insufficient taxpayer interest.** NOTWITHSTANDING ANY 3 LAW TO THE CONTRARY, FOR CALENDAR YEARS BEGINNING ON OR AFTER January 1, 2031, the office may determine that there is 4 5 INSUFFICIENT TAXPAYER INTEREST TO CONTINUE OFFERING THE TAX 6 CREDIT PURSUANT TO THIS SECTION. AFTER THE OFFICE MAKES SUCH A 7 DETERMINATION, IT SHALL NOT ACCEPT ANY MORE APPLICATIONS FOR TAX 8 CREDITS PURSUANT TO THIS SECTION AND IT SHALL INFORM THE 9 DEPARTMENT THAT IT HAS DISCONTINUED THE CREDIT.".
- 10 Renumber succeeding subsection accordingly.
- 11 Page 18, strike lines 13 and 14 and substitute:
- 12 "(a) "COAL TRANSITION COMMUNITY" MEANS A TIER ONE
 13 TRANSITION COMMUNITY AS DEFINED IN SECTION 8-83-502 (10).".
- 14 Page 18, line 25, strike "2034." and substitute "2038.".
- 15 Page 19, line 5, after "DEPARTMENT" insert "OF TRANSPORTATION".

Page 20, line 7, after "SECTION," insert "AND SUBJECT TO THE LIMITATIONS
SET FORTH IN SUBSECTION (5) OF THIS SECTION,".
