After consideration on the merits, the Committee recommends the following:

HB25-1149 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 3, lines 9 and 10, strike "FOR SCHOOL YEARS
2 BEGINNING ON OR AFTER JULY 1, 2028, EACH" and substitute "EACH".

- 3 Page 3, line 13, strike "STUDENTS." and substitute "STUDENTS, FOR THE
4 SCHOOL YEAR IMMEDIATELY FOLLOWING THE INITIAL ADOPTION OF THE
5 STANDARDS PURSUANT TO THE SCHEDULE DESCRIBED IN SECTION
6 22-7-1005 (6) AND EVERY SCHOOL YEAR THEREAFTER."

- 7 Page 3, lines 14 and 15, strike "TAKE INTO CONSIDERATION" and substitute
8 "IMPLEMENT".

- 9 Page 3, lines 22 and 23, strike "ON OR BEFORE JULY 1, 2026," and
10 substitute "PURSUANT TO THE STANDARDS SCHEDULE DESCRIBED IN
11 SUBSECTION (6) OF THIS SECTION,".

- 12 Page 4, line 1, strike "USE" and substitute "IMPLEMENT".

- 13 Page 5, line 9, strike "USED" and substitute "IMPLEMENTED".

- 14 Page 8, line 4, strike "CONSIDER" and substitute "IMPLEMENT".

- 15 Page 8, line 15, strike "MAY" and substitute "SHALL".

- 16 Page 9, after line 10 insert:
17 "(c) IN MAKING RECOMMENDATIONS PURSUANT TO SUBSECTION
18 (6)(a) OF THIS SECTION, THE COMMITTEE SHALL:
19 (I) EVALUATE THE MOST RECENT REVISIONS TO THE STATE'S
20 HISTORY AND CIVICS STANDARDS THAT REFLECT THE RECOMMENDATIONS

1 PROVIDED BY THE HISTORY, CULTURE, SOCIAL CONTRIBUTIONS, AND CIVIL
2 GOVERNMENT IN EDUCATION COMMISSION ESTABLISHED IN SECTION
3 22-1-104.3; AND

4 (II) INCLUDE RECOMMENDATIONS FOR ANY UPDATES NECESSARY
5 TO MAKE THE STATE'S HISTORY AND CIVICS STANDARDS CURRENT,
6 ACCURATE, COMPREHENSIVE, AND ALIGNED WITH THE COMMITTEE'S
7 OTHER RECOMMENDATIONS."

8 Strike "COMMISSION" and substitute "COMMITTEE" on: **Page 7**, lines 8 and
9 14.
