After consideration on the merits, the Committee recommends the following:

HB25-1220 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend page 4, strike lines 23 through 27.
- 2 Page 5, strike lines 1 through 9.
- 3 Renumber succeeding subsections accordingly.
- 4 Page 8, after line 2 insert:
 - 5 "(13) "NUTRITION DIAGNOSIS" MEANS IDENTIFYING AND LABELING
 - 6 NUTRITION PROBLEMS MANAGED AND TREATED BY A LICENSED DIETITIAN
 - 7 OR A LICENSED NUTRITIONIST BUT DOES NOT INCLUDE A MEDICAL
 - 8 DIAGNOSIS OF THE HEALTH STATUS OF AN INDIVIDUAL."
- 9 Renumber succeeding sections accordingly.
- 10 Page 15, lines 7 through 10, strike "ON AND AFTER SEPTEMBER 1, 2026,
- 11 AN INDIVIDUAL WHO PRACTICES AS A DIETITIAN OR WHO HOLDS THEMSELF
- 12 OUT AS BEING ABLE TO PRACTICE AS A DIETITIAN MUST POSSESS A VALID
- 13 LICENSE ISSUED PURSUANT TO THIS ARTICLE 223. EACH" and substitute
- 14 "AN".
- 15 Page 18, lines 22 through 26, strike "ON AND AFTER SEPTEMBER 1, 2026,
- 16 AN INDIVIDUAL WHO PRACTICES AS A NUTRITIONIST OR WHO HOLDS
- 17 THEMSELF OUT AS BEING ABLE TO PRACTICE AS A NUTRITIONIST MUST
- 18 POSSESS A VALID LICENSE ISSUED PURSUANT TO THIS ARTICLE 223. EACH"
- 19 and substitute "AN".
- 20 Page 27, lines 18 through 20, strike "OR USE OR ASSUME THE TITLE
- 21 "DIETITIAN", "DIETITIAN NUTRITIONIST", OR "DIETICIAN", OR ANOTHER

1 TITLE INDICATING THAT THE INDIVIDUAL IS A LICENSED DIETITIAN,".

2 Page 27, line 21, after "223." add "AN INDIVIDUAL SHALL NOT USE OR
3 ASSUME THE TITLE "DIETITIAN", "DIETITIAN NUTRITIONIST", OR
4 "DIETICIAN" UNLESS THE INDIVIDUAL HOLDS THE REGISTERED DIETITIAN
5 CREDENTIAL FROM THE COMMISSION ON DIETETIC REGISTRATION OR IS
6 LICENSED AS A DIETITIAN UNDER THIS ARTICLE 223."

7 Page 28, lines 11 through 13, strike "OR IDENTIFY THEMSELF USING THE
8 GENERAL TITLES OF "DIETITIAN", "DIETITIAN NUTRITIONIST", OR
9 "NUTRITIONIST"

10 Page 36, lines 8 through 11, strike "AS A DIETITIAN OR A NUTRITIONIST, OR
11 AN INDIVIDUAL WHO PRACTICES OR OFFERS OR ATTEMPTS TO PRACTICE
12 MEDICAL NUTRITION THERAPY, WITHOUT BEING LICENSED PURSUANT TO
13 THIS ARTICLE 223" and substitute "IN VIOLATION OF SECTION 12-223-111".

14 Page 38, after line 17 insert:

15 "SECTION 5. In Colorado Revised Statutes, **repeal** 6-1-707
16 (1)(b)."

17 Renumber succeeding sections accordingly.
